- AND WHEREAS, the ERC in its 272nd meeting held on 30th 31st May & 1st June, 2019 considered the matter and as decided, Show Cause Notice u/s 17(1) was issued on 14.06.2019 to the institution on the following grounds:
 - The submitted faculty list is not in accordance with the NCTE prescribed proforma.

Building Completion certificate is not submitted. (ii)

- AND WHEREAS, in response to SCN issued to the institution dated 18.05.2019, reply of SCN not received in this office within stipulated time. Matter placed in the 274th ERC meeting held on 15^{th} – 16^{th} July 2019 and committee took decision as under:
 - a) The submitted faculty list is not in accordance with the NCTE prescribed proforma.
 - b) Building completion certificate is not submitted.

No reply received and the stipulated time period has already been over

In view of the above, the Committee decided as under:

Recognition granted to M.Ed. course is withdrawn under section 17(1) of NCTE Act, 1993 from the academic session 2020-2021.

NOW THEREFORE, recognition granted to the institution viz. M.Ed. Department of Kolhan University, Street No. 305, Vill-Chaibasa, PO-Chaibasa, Tehsil-Taluka-Chaibasa, Town-City-Chaibasa, Dist.- Paschim Singhbhum, Jharkhand-833202 (Code No.ERCAPP1932) for B.Ed. Course is hereby withdrawn under section 17(1) of NCTE Act, 1993 with effect from the academic session 2020-2021.
