WHEREAS, Govt. Hindi Teacher's Training College, imphal Manipur- 795001 (AFE00306) was granted recognition for B.Ed. (Hindi Siksna Parangat (HSP) course with an intake of 60 from the academic session 1997-1998 vide ERC's order dtd. 11.02.1997. The intake has been enhanced from 60 to 100 from the academic session 2006-2007 vide ERC's order dated 04.01.2006, followed by revised order vide No. 31794 dated 20.05.2015 from the academic session 2015-2016 as per NCTE Regulations, 2014 subject to fulfilment of the conditions in respect of enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintain and update website and to comply the same to the ERC.

- 2. **AND WHEREAS**, the ERC in its 198th meeting held on 20th 21st Nov, 2015 considered the representation dated 30.07.2017 from Director, University and Higher Education Govt. of Manipur and as decided, a letter vide No. 39507 dtd. 04.12.2015 was issued to the institution with reducing intake of B.Ed. Course from two basic units to one basic unit i.e. **50 intake** from the academic session **2016-2017**.
- 3. **AND WHEREAS**, the ERC in its 274th meeting held on 15th 16th July, 2019 considered the matter and observed that 1st show cause notice u/s 17(1) issued on 21.02.2019, followed by final show cause notice dated 18.05.2019 on the following grounds:
 - (i) Approved faculty list by the concerned affiliating body along with requisite documents.
 - (ii) Approved building plan by the concerned competent Govt. Engineer/Authority.
 - (iii) Approved building completion certificate by the concerned competent Govt. Engineer/ Authority.
 - (iv) FDRs towards Endowment fund and Reserve fund after conversion into joint operation mode as prescribed in the NCTE Regulations, 2014.
 - (v) Confirmation on website updates of the institutions with all details along with affidavit.

No reply received and the stipulated time period has already been over.

Recognition granted to **B.Ed. course** is **withdrawn** under section 17(1) of NCTE Act, 1993 from the academic session 2020-2021.

5. NOW THEREFORE, recognition granted to the institution viz. Govt. Hindi Teacher's Training College, Imphal, Manipur - 795001 (Code No. APE00306) for B.Ed. (Hindi Siksha Parangat (HSP) Course is hereby withdrawn under section 17(1) of NCTE Act, 1993 from the academic session 2020-2021.
