### Order

In terms of Section 14(1) of the NCTE Act, 1993 **Thockchom Ibotombi Institute of Teacher Education and Training, P.O. Bishnupur, Manipur, Pin – 795 126** had submitted an application to the Eastern Regional Committee of NCTE for grant of recognition for starting B.Ed. Course of One year duration from the academic session 2003-2004 with an annual intake of 100 (One hundred) students.

2. The institution was refused recognition vide order dated 13.5.2003 and the institution preferred an appeal to the Council and the Appeal Committee has remanded back this case to ERC vide order dated 21.10.2003.

3. On scrutiny of the application submitted by the institution, the documents attached therewith and the input received from the visiting team, the list of teaching staff submitted by the institution, and observations of the Council in its order in appeal dated 21.10.2003, the Committee reconsidered and noted the following:

- i) The institution has acquired the land for setting up the teacher education institution.
- ii) The institution has constructed the building for conducting the course on the above mentioned land.
- iii) The institution has created an Endowment Fund of Rs. 5.00 lakhs and a Reserve Fund of Rs. 2.62 lakhs.
- iv) The institution has appointed the Principal and 13 (thirteen) teachers for the said course and the list of faculty members has also been approved by the affiliating University.


4. Now, therefore, in exercise of the powers vested under Section 14(3) (a) of the NCTE Act, 1993, the Regional Committee hereby grants recognition to **Thockchom Ibotombi Institute of Teacher Education and Training, P.O. Bishnupur, Manipur, Pin – 795 126** for **B.Ed.** Course of **One** year duration from the academic session **2003-2004** with an annual intake of **100 (One hundred)** students subject to fulfillment of the following:

- a. That the institution will ensure that **Principal** and at least **07 (seven)** faculty members duly approved by the affiliating University are in position for an intake of **100 (One hundred)** students before commencement of the course and a report to this effect shall be sent to the Eastern Regional Committee within one month of commencement of the course.
- b. The institution shall, within one month of the receipt of recognition order, convert the endowment fund account into a joint account to be operated along with an official of the Eastern Regional Committee.
- c. The institution shall comply with the various other norms and standards prescribed in the NCTE regulations.

5. Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC and the State Government etc.
6. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along with a copy of the approval of the affiliating university to the appointment of faculty members, and the statement of annual accounts duly audited by a Chartered Accountant.
7. If the institution contravenes any of the above conditions or any of the provisions of the NCTE Act, Rules, Regulations and Orders made or issued thereunder, the Regional Committee may withdraw the recognition under the provisions of Section 17(1) of the NCTE Act.
