ORDER

WHEREAS, Thockchom Ibotombi Institute of Teacher Education and Training, Bishnupur, Manipur 795126 (MP-S/N-3/2002-Appeal) was granted recognition for conducting B.Ed. course with an intake of 60 from the academic session 2000-2001 vide ERC's order dated 14.01.2000. The intake was enhanced from 60 to 100 from the academic session 2003-2004 vide ERC's order dated 12.12.2003, followed by revised order dated 20.05.2015 from the academic session 2015-2016 as per NCTE Regulations, 2014 subject to fulfilment of the conditions in respect of enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintain and update website and to comply the same to the ERC.

2. **AND WHEREAS**, the ERC in its 255th Meeting held on 30th April to 2nd May, 2018 considered the matter and Show Cause Notice u/s 17(1) was issued on 10.05.2018 to the institution on the following grounds:-

- (i) Faculty list duly approved by the concerned affiliating body not submitted. In the submitted faculty list, the institution appointed 13 lecturers against the requirement of 16 as per NCTE Regulations, 2014.
- (ii) Building completion certificate duly approved by the Govt. Engineer is not submitted.
- (iii) Blue print of building plan in original duly approved by the Govt. Engineer is not submitted.
- (iv) FDRs towards Endowment and Reserve fund after conversion into joint mode not submitted.
- (v) Converted FDRs in joint operation mode is required to be uploaded on institution website.
- (vi) Institution website address not mentioned and updated.

3. **AND WHEREAS**, the institution had failed to submit reply in response to SCN dated 10.05.2018 within the stipulated time. The ERC in its 271st meeting held on 24th - 25th April, 2019 considered the matter and final show cause Notice u/s 17(1) was issued on 18.05.2019 to the institution to comply the deficiencies mentioned in the SCN dated 10.05.2018.

4. **AND WHEREAS**, the ERC in its 275th Meeting held on 26th July, 2019 considered the matter along with the reply dated 01.06.2019 from the institution in response to final show cause notice and the institution is still deficient on the following grounds:-

- (i) Qualified faculty comprises 1+11 instead of 1+15 as per NCTE Regulations, 2014 for running 100 intake of B.Ed. course.

- (ii) Faculties at sl. No.12, 13, 14 & 15 appointed after 09.06.2017 for Pedagogy subjects do not have NET/Ph.D. qualification as per Gazette Notification No.237 of NCTE published on 09.06.2017.

The intake for **B.Ed. course be reduced from 100 to 50 from the academic session 2020-2021** with intimation to the institution and all concerned.


