Order

In terms of Section 15(1) of the NCTE Act, 1993 D.M.College of Teacher Education, Imphal, Imphal East – 795 001, Manipur had submitted an application to the Eastern Regional Committee of NCTE for grant of recognition for starting M.Ed. course of one year duration from the academic session 2003-2004 with an annual intake of 25 (twenty five) students.

2. On scrutiny of the application submitted by the institution, the documents attached therewith, the inputs received from the visiting team, the Committee has noted the following:

- i. The institution has acquired the land for setting up the teacher education institution.
- ii. The institution has constructed the building for conducting the course on the above mentioned land.
- iii. The list of faculty members in the prescribed format has not been countersigned by the concerned affiliating university.

3. Now, therefore, in exercise of the powers vested under Section 15(3) (a) of the NCTE Act, 1993, the Regional Committee hereby grants recognition to **D.M.College of Teacher Education, Imphal, Imphal East – 795 001, Manipur** for M.Ed. course of one year duration from the academic session **2005-2006** with an annual intake of **25 (twenty five)** students subject to fulfillment of the following conditions:

- a. The institution shall ensure that one HOD and three Reader/Lecturers are in position before the commencement of the M.Ed. course and a report to this effect shall be sent to the ERC before the commencement of the course.
- b. The institution shall submit a list of teachers duly counter signed by the competent authority of the affiliating University in the prescribed format within one month from the commencement of the course.
- c. The institution shall pay salary to the teaching staff as prescribed by UGC /State Govt.
- d. The institution shall comply with the various other norms and standards prescribed in the NCTE regulations.

4. Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC, the State Government etc.

5. The institution shall submit to the Regional Committee a Performance Appraisal Report at the end of each academic year along with a copy of the approval of the affiliating University to the appointment of faculty members, and the statement of annual accounts duly audited by a Chartered Accountant.

6. If the institution contravenes any of the above conditions or any of the provisions of the NCTE Act, Rules, Regulations and Orders made or issued thereunder, the Regional Committee may withdraw the recognition under the provisions of Section 17(1) of the NCTE Act.


