ORDER

WHEREAS the Eastern Regional Committee (ERC), National Council for Teacher Education, Bhubaneshwar in its Order No. ERC/7-30(ER-30.8.3(4)/2002/4341(1) dated the 16th December, 2002 (hereinafter referred to as the Order) refused permission to St. Mary College of Teacher Education, Boyce Road, Laitumkhrah, Shillong, East Khasi Hills, Meghalaya – 793 003 for additional intake in B.Ed course on the ground that Endowment Fund of Rs.5 lakhs has not been placed under Fixed Deposit and joint operation with an officer of ERC.

AND WHEREAS the Principal, St. Mary College of Teacher Education, Shillong, (hereinafter referred to as the appellant) preferred an appeal dated the 2nd February, 2003 to the National Council for Teacher Education, New Delhi (hereinafter referred to as the Council) under Section 18 of the NCTE Act, 1993 against the said Order.

AND WHEREAS Sister Biola Shadap, Principal, St. Mary College of Teacher Education presented the case of the appellant institution on the 13th March, 2003. The submissions made in the appeal are that (i) opening of Joint Fixed Deposit Account was completed by 31st December, 2002 and sent to ERC thereafter; (ii) the institution is functioning since 1937; and (iii) the request for additional intake was in compliance with the order of the State Government dated the 6th March, 2002 to all colleges of teacher education in the State of Meghalaya to increase the number of teacher trainees to 125. In the course of personal presentation it has been submitted that there are 7 teachers.
