- 2. **AND WHEREAS,** the ERC in its 271st meeting held on $24^{th} 25^{th}$ April, 2019 considered the matter and as decided, Show Cause Notice u/s 17(1) was issued on 18.05.2019 to the institution on the following grounds:
 - (i) Approved faculty list (current) by the concerned affiliating body along with requisite documents.
 - (ii) Approved building plan by the concerned competent Govt. Engineer/Authority.
 - (iii) Approved building completion certificate by the concerned competent Govt. Engineer/Authority.
 - (iv) FDRs towards Endowment fund and Reserve fund after conversion into joint operation mode as prescribed in the NCTE Regulation, 2014.
 - (v) Confirmation on website updates of the institutions with all details along with affidavit.
- 3. **AND WHEREAS**, in response to SCN issued to the institution dated 18.05.2019, reply of SCN not received in this office within stipulated time. Matter placed in the 274th ERC meeting held on 15th 16th July 2019 and committee decided to withdraw recognition on the above points.
 - ➤ Hence, Recognition granted to **B.Ed.** course is withdrawn under section 17(1) of NCTE Act, 1993 from the academic session 2020-2021.
- 4. NOW THEREFORE, recognition granted to the institution viz. Qoumrul Hoque School of Education University of Science and Technology, Plot No.52, St.No.101, Vill-Baridua, P.O. Killing Centre, Tehsil/Taluka-Ri Bhoi Town/City-Techno City, Dist-Ri Bhoi, Meghalaya-793101 (Code No.ERCAPP45/2012) for B.Ed. Course is hereby withdrawn under section 17(1) of NCTE Act, 1993 with effect from the academic session 2020-2021.
