#### Order

In terms of Section 14(1) of the NCTE Act, 1993 **Don Bosco College of Teacher Education, At/P.O. Tura, Dist. West Garo Hills, Meghalaya, Pin – 794 002** had submitted an application to the Eastern Regional Committee of NCTE for grant of recognition for starting B.Ed. Course of One year duration from the academic session 2004 (starting from January, 2004) with an annual intake of 100 (One hundred) students.

2. On scrutiny of the application submitted by the institution, the documents attached therewith and the input received from the visiting team, the Committee has noted the following:

- i) The institution has acquired the land for setting up the teacher education institution.
- ii) The institution has made arrangements for conducting the course in one wing of the own building of the management for the proposed institution.
- ii) The institution has created an Endowment Fund of Rs. 5.00 lakhs and a Reserve Fund of Rs. 3.00 lakhs
- iii) The institution has selected the Principal-cum-Secretary (on ad-hoc basic) and 07(seven) teachers for the said course and the list of faculty members has also been approved by the affiliating University i.e. Director, College Development Council, North Eastern Hill University, Shillong.


3. Now, therefore, in exercise of the powers vested under Section 14(3) (a) of the NCTE Act, 1993, the Regional Committee hereby grants recognition to **Don Bosco College of Teacher Education, At/P.O. Tura, Dist. West Garo Hills, Meghalaya, Pin – 794 002 for B.Ed. Course of one year duration from the academic session 2005 (starting from January, 2005) with an annual intake of 100 (One hundred) students subject to fulfillment of the following:**

- a. That the institution will ensure that **Principal** and at least **07 (seven)** faculty members qualified as per NCTE norms duly approved by the affiliating University i.e. Registrar, North Eastern Hill University, Shillong are in position for an intake of **100 (One hundred)** students before commencement of the course and a report to this effect shall be sent to the Eastern Regional Committee within one month of commencement of the course.
- b. The institution shall, within one month of the receipt of recognition order, convert the endowment fund account into a joint account to be operated along with an official of the Eastern Regional Committee.
- c. The institution shall comply with the various other norms and standards prescribed in the NCTE regulations.

4. Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC and the State Government etc.
5. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along with a copy of the approval of the affiliating university to the appointment of faculty members, and the statement of annual accounts duly audited by a Chartered Accountant.
6. If the institution contravenes any of the above conditions or any of the provisions of the NCTE Act, Rules, Regulations and Orders made or issued thereunder, the Regional Committee may withdraw the recognition under the provisions of Section 17(1) of the NCTE Act.


