- 2. **AND WHEREAS**, the ERC in its 272nd meeting held on 30th, 31st May & 01st June'2019 considered the matter along with the reply dated 14.03.2019, 12.04.2019 & 23.04.2019 submitted by the institution in response to Show Cause Notice and observed as under:
 - i. Show Cause Notice u/s 17(1) were issued on 21.02.2019 & 14.05.2019.
 - ii. The institution has failed to submit compliance of conditions mentioned in the SCN within the stipulated period and no supporting document submitted.

In view of the above, the Committee decided as under:-

The Committee is of the opinion that recognition granted to **B.Ed. course** of the application bearing **Code No.APE00244** (File No.ME-S/N-2/2003) is withdrawn under section 17(1) of NCTE Act, 1993 from the academic session 2020-2021.

3. NOW THEREFORE, recognition granted to Don Bosco College of Teacher Education, Tura, West Garo Hills, Meghalaya—794002 Code No.APE00244 (File No.ME-S/N-2/2003) for B.Ed. Course is hereby withdrawn in terms of 17(1) of NCTE Act, 1993 with effect from the academic session 2020-2021.
