ORDER

WHEREAS, Bosco College of Teacher Education, Dimapur, Nagaland-797112 (B.Ed.) (APE00168) was granted recognition for conducting B.Ed. course from time to time with an intake of 100 from the academic session 2003-2004 vide ERC order dated 28.01.2003, followed by revised order dated 23.05.2015 from the academic session 2015-2016 as per NCTE Regulations, 2014 subject to fulfilment of the conditions in respect of enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintain and update website and to comply the same to the ERC.

2. AND WHEREAS, the ERC in its 274th meeting held on 15th - 16th July, 2019 considered the matter that 1st show cause notice u/s 17(1) issued on 20.04.2018, followed by final show cause notice dated 18.05.2019 and the institution is still deficient on the following ground:-

- (i) Faculty list comprises 1+13 as against the requirement of 1+15 as per NCTE Regulations, 2014 for running 100 intake of B.Ed. course and appointed only 01 Mathematics teacher.

The intake for B.Ed. course be reduced from 100 to 50 from the academic session 2020-2021 with intimation to the institution and all concerned.
