ORDER

WHEREAS, State College of Teacher Education, Plot No.-067, P.O.- Kohima, Tehsil/Taluka-Kohima, Town/City-Kohima, Dist.- Kohima, Nagland-797001 (ERCAPP1419) was granted recognition for M.Ed. course with an intake of 35 from the academic session 2014-2015 vide ERC Order No. 21793 dated 08.11.2013, followed by revised order with an intake of 50 (one basic unit) from the academic session 2015-2016 vide No.31791 dated 20.05.2015 as per NCTE Regulations, 2014 subject to fulfilment of the conditions in respect of enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintain and update website and to comply the same to the ERC.

- 2. **AND WHEREAS**, the ERC in its 254^{th} Meeting held on 16^{th} 17^{th} April, 2018 considered the matter and Show Cause Notice u/s 17(1) was issued on 20.04.2018 to the institution on the following grounds:-
 - (i) Approved faculty list (current) by the concerned affiliating body along with requisite documents.

(ii) Approved building plan by the concerned competent Govt. Engineer/Authority.

(iii) Approved building completion certificate by the concerned competent Govt. Engineer/Authority.

(iv) FDRs towards Endowment fund and Reserve fund after conversion into joint operation mode as prescribed in the NCTE Regulations, 2014.

(v) Confirmation on website updates of the institutions with all details along with affidavit.

- 3. **AND WHEREAS**, the institution had failed to submit reply in response to SCN dated 20.04.2018 within the stipulated time. The ERC in its 271st meeting held on 24th -25th April, 2019 considered the matter and final show cause Notice u/s 17(1) was issued on 18.05.2019 to the institution to comply the deficiencies mentioned in the SCN dated 20.04.2018.
- 4. **AND WHEREAS**, the ERC in its 275th Meeting held on 26th July, 2019 considered the matter along with the reply dated 19.06.2019 from the institution in response to final show cause notice and the institution is still deficient on the following grounds:-
 - (i) Principal and other faculty members are not as per NCTE Regulations, 2014. Faculty comprises 1+8 against the requirement of 1+10 as per NCTE Regulations, 2014.

(ii) Building plan and building completion certificate are not submitted.

Recognition granted to M.Ed. course is withdrawn under section 17(1) of NCTE Act, 1993 from the academic session 2020-2021.
