**ORDER**

WHEREAS, Rashtriya Sanskrit Sansthan (Deemed University), Sree Sadashiva Campus, Puri, Odisha - 752001 (Code No. APE00431, APE00972 & ERCAPP4019) was granted recognition for Shiksha Sastri (B.Ed.) course of one year duration with an annual intake of 100 vide ERC order No. ERC/7-56.5.3/2005/14845 dated 12.05.2005 and vide order dated 31.08.2009 granted permission of additional intake of 27, thus making the total intake of 127. Revised order from the academic session 2015-2016 with an intake of 150 (three basic units) vide dated 31.05.2015.

2. AND WHEREAS, the institution was granted permission of additional intake of 50 students, (existing 150 intake + additional 50 intake), thus making the total intake of 200 (two hundred) from the academic session 2017-2018 under clause 7(16) of NCTE (Recognition Norms & Procedure) Regulations, 2014 subject to fulfilment of the conditions in respect of enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintain and update website and to comply the same to the ERC.

3. AND WHEREAS, the ERC in its 254<sup>th</sup> meeting held on 16<sup>th</sup> - 17<sup>th</sup> April, 2018 considered the matter and Show Cause Notice u/s 17(1) was issued on 20.04.2018 to the institution on the following grounds:


- Approved faculty list (current) by the concerned affiliating body along with requisite documents.
- Approved building plan by the concerned competent Govt. Engineer/Authority.
- Approved building completion certificate by the concerned competent Govt. Engineer/Authority.
- FDRs towards Endowment fund and Reserve fund after conversion into joint operation mode as prescribed in the NCTE Regulations, 2014.
- Confirmation on website updates of the institutions with all details along with affidavit.

4. AND WHEREAS, the ERC in its 271<sup>st</sup> Meeting held on 24<sup>th</sup> - 25<sup>th</sup> April, 2019 considered the matter and final show cause notice u/s 17(1) was issued on 18.05.2019 on the following grounds:-

- Approved faculty list (current) by the concerned affiliating body along with requisite documents.
- Approved building plan by the concerned competent Govt. Engineer/Authority.
- Approved building completion certificate by the concerned competent Govt. Engineer/Authority.
- FDRs towards Endowment fund and Reserve fund after conversion into joint operation mode as prescribed in the NCTE Regulations, 2014.
- Confirmation on website updates of the institutions with all details along with affidavit.

5. AND WHEREAS, the institution has submitted reply dt. 10.09.2019 in response to show cause notice received on 18.05.2019. The ERC in its 278<sup>th</sup> meeting 16<sup>th</sup> - 18<sup>th</sup> January, 2020 after considering the matter and observed that the institution is still deficient on the following grounds:-

- List of teaching faculty is not appointed as per NCTE Regulation, 2014.
- Requisite information of the institutional website has not updated as per clause 7(14)(i) of the NCTE Regulation, 2014.

Hence, B.Ed. (Shiksha Sastri) course is **withdrawn** under section 17(1) of NCTE Act, 1993 from the next academic session 2020-2021.

6. **NOW THEREFORE**, recognition granted to the institution viz. **Rashtriya Sanskrit Sansthan (Deemed University), Sree Sadashiva Campus, Puri, Odisha – 752001 (Code No. APE00431 & APE00972)** for B.Ed. Course is hereby **withdrawn** under section 17(1) of NCTE Act, 1993 from 2020-2021.

7. **FURTHER**, if the institution is not satisfied by the order, they can prefer an appeal Under Section 18 of the NCTE Act in the "Online mode" available on NCTE's website [www.ncte-india.org](http://www.ncte-india.org) within 60 days from the date of the issue of the order.




