- AND WHEREAS, the ERC in its 254th meeting held on 16th 17th April, 2018 considered the matter and Show Cause Notice u/s 17(1) was issued on 20.04.2018 to the institution on the following grounds:
 - a. Approved faculty list (current) by the concerned affiliating body along with requisite documents.
 - b. Approved building plan by the concerned competent Govt. Engineer/Authority.
 - c. Approved building completion certificate by the concerned competent Govt. Engineer/Authority.
 - d. FDRs towards Endowment fund and Reserve fund after conversion into joint operation mode as prescribed in the NCTE Regulations, 2014.
 - Confirmation on website updates of the institutions with all details along with affidavit.
- AND WHEREAS, the ERC in its 271st Meeting held on 24th 25th April, 2019 considered the matter and final show cause notice u/s 17(1) was issued on 18.05.2019 on the following grounds:-
 - Approved faculty list (current) by the concerned affiliating body along with requisite documents.
 - b. Approved building plan by the concerned competent Govt. Engineer/Authority.
 - Approved building completion certificate by the concerned competent Govt. Engineer/Authority.
 - d. FDRs towards Endowment fund and Reserve fund after conversion into joint operation mode as prescribed in the NCTE Regulations, 2014.
 - Confirmation on website updates of the institutions with all details along with affidavit.
- AND WHEREAS, the institution has submitted reply dt. 10.09.2019 in response to show cause notice received on 18.05.2019. The ERC in its 278th meeting 16th - 18th January, 2020 after considering the matter and observed that the institution is still deficient on the following grounds:-

List of teaching faculty is not appointed as per NCTE Regulation, 2014.

(ii) Requisite information of the institutional website has not updated as per clause 7(14)(i) of the NCTE Regulation, 2014.
