SHIFTING OF PREMISES

The institution viz. Government Teachers Training College, Phulbani, Plot No.397, 184, 380 156, Vill/PO-Phulbani, Dist-Kandhamal, Odisha-762001 granted recognition for conducting B.Ed. course with 100 intake from the academic session 2009-2010 vide order No. ERC/7-100.6(1)(1S).3/2009/1350 dated 31.08.2009 by the ERC, NCTE, followed by revised recognition order issued vide No. 32686 dated 31.05.2015 as per NCTE Regulations, 2014.


2. The aforesaid institution had submitted representation dated 08.03.2017 for shifting of campus along with requisite documents received at ERC NCTE on 14.03.2017.

3. The ERC in its 237th meeting held on 9th -11th August, 2017 decided that VT be constituted for shifting of premises. Accordingly, the inspection of the institution at new campus was conducted on 8th & 9th June, 2017 and VT Report received at ERC, NCTE on 12th June, 2017.

4. The ERC in its 242nd meeting held on 15th -16th July, 2017 after considering and examining the application along with the documents submitted by the institution, the agenda note, the NCTE Act., the NCTE Regulations 2014 including Norms and Standards, guidelines received from the NCTE Hqrs. from time to time and VTR, discussed the matter in detail and decided as under:

“Shifting of campus of institution from the plot Nos. 397, 184, 380, 156 to the new plot Nos. 11/224, 11/225, 98/229(P) and 98/231(P) at Khata No. 34 in the Mouza Salunki is allowed”.

5. In view of the above, the institution is hereby permitted to shift its campus from the plot Nos. 397, 184, 380, 156 to the “new plot Nos. 11/224, 11/225, 98/229(P) and 98/231(P) at Khata No. 34 in the Mouza Salunki”.
