WHEREAS, Government Teachers Training College, Phulbani, Plot No.11/224, 11/225, 98/229(P) and 98/231(P), Khata No.34, Mouza—Salunki, Vill/PO-Phulbani, Dist-Kandhamal, Odisha-762001 was granted recognition for B.Ed. course with an intake of 100 from the academic session 2009-2010 vide order dated 31.08.2009, followed by revised order dated 31.05.2015 with an intake of 100 (two basic units) from the academic session 2015-2016 as per NCTE Regulations, 2014 subject to fulfilment of the conditions in respect of enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintain and update website and to comply the same to the ERC.

- AND WHEREAS, the ERC in its 254th meeting held on 16th 17th April'2018 considered the matter and as per decision of the committee Public Notice was issued on 20.04.2018. In response to the Notice institution not submitted any reply after completion of the stipulated time over.
- AND WHEREAS, the ERC in its 271st meeting held on 24th 25th April'2019 considered the matter and as per decision of the committee again Show Cause Notice was issued to the institution on 18.05.2019. In response to Show Cause Notice institution submitted the reply dt.27.05.2019 received on 29.05.2019.
- AND WHEREAS, the ERC in its 274th meeting held on 15th 16th July'2019 4. observed that the institution is still deficient on the following grounds:
 - i. 1st Show Cause Notice u/s 17(1) issued on 20.04.2018.

ii. Final Show Cause Notice u/s 17(1) issued on 18.05.2019.

iii. Faculty list comprises 1 (Principal/HOD)+4 (lecturers) out of which 03 lecturers on part-time, which is not adequate as per NCTE Regulations, 2014 and subsequent amendment dated 09.06.2017.

In view of the above, the committee decided as under:-

Recognition granted to B.Ed. course of the application bearing Code No.APE00961 is withdrawn under section 17(1) of NCTE Act, 1993 from the academic session 2020-2021.
