ORDER

WHEREAS, Anandpur Anchalika Training College, Fakirpur, Keonjhar, Plot No.- 5475/7379 & 5476, Street No.- Ward No.-09, Vill. - Fakirpur, PO. - Fakirpur, Tehsil/Taluka - Anandapur, Town/City - Anandapur, Dist.-Keonjhar, Odisha-758022 (OR-S/E-3/96 & ERCAPP1849) was granted recognition for B.Ed. course with an intake of 100 vide orders dated 31.05.1996, 17.10.1996, 01.07.1998, 18.02.1999, 02.09.1999, 06.04.2000, 02.02.2001 and 24.02.2014 respectively, followed by revised order dated 31.05.2015 from the academic session 2015-2016 as per NCTE Regulations, 2014 subject to fulfilment of the conditions in respect of enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintain and update website and to comply the same to the ERC.

2. **AND WHEREAS**, the ERC in its 254th Meeting held on 16th - 17th April, 2018 considered the matter and Show Cause Notice u/s 17(1) was issued on 20.04.2018 to the institution on the following grounds:-

- Approved faculty list (current) by the concerned affiliating body along with requisite documents.
- Approved building plan by the concerned competent Govt. Engineer/Authority.
- Approved building completion certificate by the concerned-competent Govt. Engineer/Authority.
- FDRs towards Endowment fund and Reserve fund after conversion into joint operation mode as prescribed in the NCTE Regulations, 2014.
- Confirmation on website updates of the institutions with all details along with affidavit.

3. **AND WHEREAS**, the institution had failed to submit reply in response to SCN dated 20.04.2018 within the stipulated time. The ERC in its 271st meeting held on 24th - 25th April, 2019 considered the matter and final show cause Notice u/s 17(1) was issued on 18.05.2019 to the institution to comply the deficiencies mentioned in the SCN dated 20.04.2018.

4. **AND WHEREAS**, the ERC in its 275th Meeting held on 27th July, 2019 considered the matter along with the reply dated 10.06.2019 from the institution in response to final show cause notice and the institution is still deficient on the following grounds:-

- Principal is not appointed.
- Only four faculty members as against the requirement of 1 (Principal) + 15 (lecturers) under NCTE Regulations, 2014 and subsequent amendment dated 09.06.2017 for running 100 intake of B.Ed. course.
- One guest faculty appointed is not accepted.
- Building plan is not submitted.

Recognition granted to B.Ed. course is **withdrawn** under section 17(1) of NCTE Act, 1993 from the academic session 2020-2021.
