#### ORDER

WHEREAS, College of Teacher Education Balangir, Odisha- 767001 (Code No. OR-S/E6/96 & APE00346) was granted recognition for conducting B.Ed. courseof one year duration from the academic session 1996-1997 vide ERC's order No. 734 dated 31.05.1996.

- 2. AND WHEREAS, Revised Recognition Order (RRO) was issued for conducting B.Ed. course of two years duration with an intake of 100 (two basic units) from the academic session 2015-2016 vide ERC's No. F. ERC/NCTE/(OR-S/E6/96 & APE00346)/B.Ed. (Revised Order)/2015/32760 dated 31.05.2015 as per NCTE Regulation, 2014 subject to fulfilment of the conditions in respect of enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintain and update website and to comply the same to the ERC.
- 3. **AND WHEREAS,** a Public Notice was uploaded on ERC's website on 30.01.2018, wherein 138 TEIs have not furnished their compliance reports in respect of conditions mentioned in the Revised Recognition Orders issued on or before 31st May, 2015 on the basis of implementation of NCTE Regulations, 2014. The ERC in its 254<sup>th</sup> meeting held on 16<sup>th</sup> 17<sup>th</sup> April, 2018 considered the matter and decided, 1<sup>st</sup> Show Cause Notice was issued on 20.04.2018 to the institutionon the following grounds:
  - a. Approved faculty list (current) by the concerned affiliating body along with requisite
  - b. Approved building plan by the concerned competent Govt. Engineer/Authority.
  - c. Approved building completion certificate by the concerned competent Govt.

    Engineer/Authority.
  - d. FDRs towards Endowment fund and Reserve fund after conversion into joint operation mode as prescribed in the NCTE Regulations, 2014.
  - e. Confirmation on website updates of the institutions with all details along with affidavit.
- 4. **AND WHEREAS,** the institution submitted reply vide letter dated 27.05.2019, received in ERC, NCTE on 29.05.2019. The ERC in its 275<sup>th</sup> (Part-1) meeting held on 26<sup>th</sup> July, 2019 considered the matter and decided, Final Show Cause Notice was issued on 22.08.2019 to the institution on the following grounds:-
  - (i) Faculty list comprises 1+3 instead of 1+15 as per NCTE Regulations, 2014 for running 100 intake of B.Ed. course.

(ii) Building plan is not submitted.

(iii) Total built up area mentioned in the building completion certificate is 17750 Sq. ft. i.e. 1649.01 Sq. Mts., which is less than required 2000 Sq. Mts. as per NCTE Regulations, 2014 for running 100 intake of B.Ed. course.

- AND WHEREAS, the institution submitted reply vide letter dated 10.09.2019, received in ERC, NCTE on 16.09.2019. The ERC in its 278th meeting held on 16th - 18th January, 2020 considered the original file of the institution alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and the following observation was made:-
  - List of teaching faculty duly approved by the affiliating body has not submitted.
  - (ii) The institution has not submitted proper Building Plan (BP) mentioning the plot No., total land area and total built up area.
  - Extension of time for construction of building is not permitted as per Regulation. (iii)
  - (iv) Requisite information of the institutional website has not updated as per clause 7(14)(i) of the NCTE Regulation, 2014.

Hence, B.Ed. course is withdrawn under section 17(1) of NCTE Act, 1993 from the next academic session 2020-21,

- NOW THEREFORE, recognition granted to the institution viz. College of Teacher Education Balangir, Odisha- 767001 (Code No. OR-S/E6/96 & APE00346) for B.Ed. Course is hereby withdrawn under section 17(1) of NCTE Act, 1993 from the next academic session2020-2021.
- 7. FURTHER, if the institution is not satisfied by the order, they can prefer an appeal Under Section 18 of the NCTE Act in the "Online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of the issue of the order.
