**ORDER**

WHEREAS, College of Teacher Education, Rourkela, Plot No.-132P, Street No.- Sector-21, Vill.- Rourkela, PO. - Rourkela, Tehsil/Taluka- Rourkela, Town/City-Rourkela, Dist.- Sundargarh, Odisha-769001 (Formerly: Rourkela College of Educational Training, Rourkela, Sector-21, Nayabazar, Rourkela-769001, Odisha) (Code No. OR-S/E-9/96 & APP1868) was granted recognition for B.Ed. course from time to time with an intake of 100 vide ERC's order dated 17.10.1996, 01.07.1998, 18.02.1999, 02.09.1999, 06.04.2000, 05.02.2001 & 24.02.2014 respectively, followed by revised order from the academic session 2015-2016 with an intake of 100 (two basic units) vide dated 31.05.2015 as per NCTE Regulations, 2014 subject to fulfilment of the conditions in respect of enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintain and update website and to comply the same to the ERC.

2. **AND WHEREAS**, the ERC in its 254<sup>th</sup> meeting held on 16<sup>th</sup> - 17<sup>th</sup> April, 2018 considered the matter and Show Cause Notice u/s 17(1) was issued on 20.04.2018 to the institution on the following grounds:

- Approved faculty list (current) by the concerned affiliating body along with requisite documents.
- Approved building plan by the concerned competent Govt. Engineer/Authority.
- Approved building completion certificate by the concerned competent Govt. Engineer/Authority.
- FDRs towards Endowment fund and Reserve fund after conversion into joint operation mode as prescribed in the NCTE Regulations, 2014.
- Confirmation on website updates of the institutions with all details along with affidavit.

3. **AND WHEREAS**, the ERC in its 271<sup>st</sup> Meeting held on 24<sup>th</sup> - 25<sup>th</sup> April, 2019 considered the matter and final show cause notice u/s 17(1) was issued on 18.05.2019 on the following grounds:-

- Approved faculty list (current) by the concerned affiliating body along with requisite documents.
- Approved building plan by the concerned competent Govt. Engineer/Authority.
- Approved building completion certificate by the concerned competent Govt. Engineer/Authority.
- FDRs towards Endowment fund and Reserve fund after conversion into joint operation mode as prescribed in the NCTE Regulations, 2014.

- e. Confirmation on website updates of the institutions with all details along with affidavit.

4. **AND WHEREAS**, the institution has submitted reply dt. 27.05.2019 in response to show cause notice received on 29.05.2019. The ERC in its 275<sup>th</sup> meeting (Part 1) held on 26<sup>th</sup> July, 2019 after considering the matter and observed that the institution is still deficient on the following grounds:-

- (i) Faculty list is not as per NCTE Regulations, 2014.
- (ii) 01 (Principal) + 15 (regular faculty) required for running 100 intake of B.Ed. course as per NCTE Regulations 2014, whereas institution appointed 01 Principal I/c and 05 guest faculties, which is not accepted.
- (iii) Total built up area mentioned in the building completion certificate as 10406 Sq. ft. i.e. 966.74 Sq. Mts., which is less than required 2000 Sq. Mts. as per NCTE Regulations, 2014 for running 100 intake of B.Ed. course.

Recognition granted to B.Ed. course is **withdrawn** under section 17(1) of NCTE Act, 1993 from the academic session **2020-2021**.

5. **NOW THEREFORE**, recognition granted to the institution viz. **College of Teacher Education, Rourkela, Plot No.-132P, Street No.-Sector-21, Vill.- Rourkela, PO. - Rourkela, Tehsil/Taluka- Rourkela, Town/City-Rourkela, Dist.- Sundargarh, Odisha-769001 (Code No. OR-S/E-9/96 & APP1868) for B.Ed. Course** is hereby **withdrawn** under section 17(1) of NCTE Act, 1993 from **2020-2021**.

6. **FURTHER**, if the institution is not satisfied by the order, they can prefer an appeal Under Section 18 of the NCTE Act in the "Online mode" available on NCTE's website [www.ncte-india.org](http://www.ncte-india.org) within 60 days from the date of the issue of the order.


