**ORDER**

**WHEREAS, Govt. College of Physical Education, Kulundi, Sambalpur, Odisha (OR-S/N-1/2000)** was granted recognition for **B.P.Ed.** course with an intake of 30 from the academic session 2001-2002 vide ERC Order No. 1654 dated 15.06.2001, followed by revised order vide No:32702 dated 31.05.2015 with an intake of 100 from the academic session 2015-2016 as per NCTE Regulations, 2014 subject to fulfilment of the conditions in respect of enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintain and update website and to comply the same to the ERC.

2. **AND WHEREAS,** the ERC in its 271<sup>st</sup> meeting held on 24<sup>th</sup> – 25<sup>th</sup> April, 2019 considered the matter and as decided, Show Cause Notice u/s 17(1) was issued on 21.05.2019 to the institution on the following grounds:

- (i) As per the list, faculty comprises 1+4 instead of 1+14 as per NCTE Regulations, 2014. Approved faculty list in accordance with NCTE prescribed proforma countersigned by the affiliating body is not submitted.

3. **AND WHEREAS,** the ERC in its 275<sup>th</sup> Meeting held on 27<sup>th</sup> July, 2019 considered the matter and reply dated 11.06.2019 from the institution in response to Show Cause Notice dated 21.05.2019 and observed as under.

1<sup>st</sup> show cause notice u/s 17(1) issued on 21.02.2019, followed by final show cause notice dated 21.05.2019 and the institution is still deficient on the following ground:-

- (i) Faculty list comprises 1+3, which is less as per NCTE Regulations, 2014 for running 100 intake of B.P.Ed. course.

Recognition granted to **B.P.Ed. course** is **withdrawn** under section 17(1) of NCTE Act, 1993 **from the academic session 2020-2021.**

4. **NOW THEREFORE,** recognition granted to the institution viz. **Govt. College of Physical Education, Kulundi, Sambalpur, Odisha (Code No. OR-S/N-1/2000)** for **B.P.Ed. Course** is hereby **withdrawn** under section 17(1) of NCTE Act, 1993 **from the academic session 2020-2021.**
