ORDER

WHEREAS, Govt. College of Physical Education, Kalinga Stadium, Nayapalli, Bhubaneswar, Odisha-751012 (OR-SO/N-2/2000) was granted recognition for conducting B.P.Ed. course of one year duration with an intake of 64 from the academic session 2001-2002 vide ERC Order No.1416 dated 11.05.2001. Revised recognition order for conducting B.P.Ed. course of two years duration for one basic unit of 100 students with two sections of 50 each from the academic session 2015-2016 vide No.32679 dated 31.05.2015 as per NCTE Regulations, 2014 subject to fulfilment of the conditions in respect of enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintain and update website and to comply the same to the ERC.

2. **AND WHEREAS**, the ERC in its 263rd meeting held on 15th – 16th November, 2018 considered the matter and as decided, - Show Cause Notice u/s 17(1) was issued on 28.11.2018 to the institution on the following grounds:-

- Show Cause Notice u/s 17(1) was issued on 20.04.2018 for submission of approved faculty list, building plan, building completion certificate and information pertaining to maintenance & updation of website of the institution.
- The institution informed vide letters dated 02.05.2018 and 17.05.2018 seeking extension of time for compliance of deficiencies mentioned in the SCN.
- The Committee has allowed 21 days time.

3. **AND WHEREAS**, the matter was placed before the Committee in its 275th ERC meeting held on 27th July, 2019 considered the matter and reply dtd.10.01.2019 submitted by the institution received on 11.01.2019 in response to the SCN dtd.28.11.2018 and Committee took the decision as under:-

1st show cause notice u/s 17(1) issued on 20.04.2018, followed by final show cause notice dated 28.11.2018 and the institution is still deficient on the following grounds:-

- Faculty list is not in NCTE Prescribed proforma and not as per NCTE Regulations, 2014 for running 100 intake of B.P.Ed. course.
- Building plan and building completion certificate approved by Govt. Engineer are not submitted. Recognition granted to B.P.Ed. course is withdrawn under section 17(1) of NCTE Act, 1993 from the academic session 2020-2021.
