- b) The institution shall pay salary to the teaching staff as prescribed by State Govt./affiliating body through Account Payee Cheque.
- c) The number of administrative staff shall be maintained as per NCTE norms. The qualifications of technical support staffs shall be maintained as per norms prescribed by NCTE. The qualifications of the administrative staff shall be maintained as per norms prescribed by NCTE.
- d) The institution shall obtain affiliation from the examining body before the commencement of the course.
- e) The institution shall maintain and update their website as per NCTE regulations.
- f) The intake, eligibility and admission procedure shall be strictly adhered as per NCTE norms.
- g) Performance Appraisal Report shall be submitted by the end of every academic year on the prescribed format.
- h) The institution shall submit affidavit of Rs.100/- on non-judicial stamp paper duly attested by Notary/ First Class Magistrate on the prescribed format (attached) as per NCTE regulations.
- i) The institution shall adhere to all the other regulations and guidelines as framed by NCTE from time to time.
- 4. Further, the permission is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC and the State Government etc, wherever applicable.
- 5. The institution shall submit to the Eastern Regional Committee a Self Appraisal Report at the end of each academic year along the statement of annual accounts duly audited by a Charted Accountant.
