

- b) The institution shall pay salary to the teaching staff as prescribed to State Govi. Autiliating body through Account Payce Cheque.
- c) The number of administrative staff shall be maintained as per 1900s norms. The qualifications of technical support staffs shall be maintained as per norms prescribed by NCTE. The qualification of the administrative staff shall be maintained as per norms prescribed by NCTE.
- d) The institution shall obtain affiliation from the examining beay before the commencement of the course.
- e) The institution shall launch its website as per para 7(6) of regulations and shall maintain and update the website as per NCTE regulation.
