ORDER

WHEREAS, Radhanath Institute of Advanced Studies in Education, Po-Chandni Chowk, Cuttack, Odisha-753002 (OR-SO/E-3/99) was granted recognition for M.Ed. course with an intake of 24 vide ERC order dated 06.04.2000, followed by revised recognition order from the academic session 2015-2016 with an intake of 50 (one basic unit) vide dated 31.05.2015 as per NCTE Regulations, 2014 subject to fulfilment of the conditions in respect of enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintain and update website and to comply the same to the ERC.

2. AND WHEREAS, the ERC in its 267th meeting held on 10th – 11th February, 2019 considered the matter and Show Cause Notice u/s 17(1) was issued on 21.02.2019 to the institution on the following grounds:

- Approved faculty list (current) by the concerned affiliating body along with requisite documents.
- Approved building plan by the concerned competent Govt. Engineer/Authority.
- Approved building completion certificate by the concerned competent Govt. Engineer/Authority.
- FDRs towards Endowment fund and Reserve fund after conversion into joint operation mode as prescribed in the NCTE Regulations, 2014.
- Confirmation on website updates of the institutions with all details along with affidavit.

3. AND WHEREAS, the institution has submitted reply dt. 18.03.2019 & 01.05.2019 in response to show cause notice issued by ERC letter dated 21.02.2019. The ERC in its 272nd Meeting held on 30th – 31st May & 1st June, 2019 considered the matter and final show cause notice u/s 17(1) was issued on 18.06.2019 on the following grounds:-


- Points mentioned in the show cause notice not complied properly for running one unit of M.Ed. course.
- The submitted faculty list for M.Ed. course is not in accordance with NCTE Regulations, 2014.

4. AND WHEREAS, the ERC in its 278th meeting held on 16th – 18th January, 2020 after considering the matter and observed that the institution is still deficient on the following grounds:-

- Non-compliance of final show cause notice issued on 18.06.2019.

Hence, M.Ed. course is withdrawn under section 17(1) of NCTE Act, 1993 from the next academic session 2020-2021.

5. **NOW THEREFORE**, recognition granted to the institution viz. **Radhanath Institute of Advanced Studies in Education, Po-ChandniChowk, Cuttack, Odisha-753002 (M.Ed.)(OR-SO/E-3/99)forM.Ed. Course** is hereby **withdrawn** under section 17(1) of NCTE Act, 1993 from 2020-2021.

6. **FURTHER**, if the institution is not satisfied by the order, they can prefer an appeal Under Section 18 of the NCTE Act in the "Online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of the issue of the order.


