**Order**

In terms of Section 15(1) of the NCTE Act, 1993 Baliapal College of Physical Education, Baliapal, Balasore – 756 026, Orissa had submitted an application to the Eastern Regional Committee of NCTE for grant of recognition for starting M.P.Ed. course of two year duration from the academic session 2003-2004 with an annual intake of 32 (thirty two) students.

2. On scrutiny of the application submitted by the institution, the documents attached therewith, the inputs received from the visiting team, the Committee has noted the following:

- i. The institution has acquired the land for setting up the teacher education institution.
- ii. The institution has constructed the building for conducting the course on the above mentioned land.
- iii. The institution has selected Principal and 04 (Four) lecturers for the said course and the list of faculty members have been approved by the concerned affiliating university.

3. Now, therefore, in exercise of the powers vested under Section 15(3) (a) of the NCTE Act, 1993, the Regional Committee hereby grants recognition to **Baliapal College of Physical Education, Baliapal, Balasore – 756 026, Orissa** for M.P.Ed. Course of two year duration from the academic session **2005-2006** with an annual intake of **30 (thirty)** students subject to fulfillment of the following:

- a. The institution will ensure that the Head in the rank of Professor/ Reader and at least 04 (four) Reader/ Lecturers duly approved by the affiliating body are in position for an intake of 30 students before the commencement of the course and a report to this effect shall be sent to the Eastern Regional Committee.
- b. The institution shall, within one month of the receipt of recognition order, convert the endowment fund account into a joint account to be operated along with an official of the Eastern Regional Committee.
- c. The institution shall pay salary to the teaching staff as prescribed by State Govt./ UGC.
- d. The institution shall comply with the various other norms and standards prescribed in the NCTE regulations.

4. Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC, the State Government etc.
5. The institution shall submit to the Regional Committee a Performance Appraisal Report at the end of each academic year along with a copy of the approval of the affiliating University to the appointment of faculty members, and the statement of annual accounts duly audited by a Chartered Accountant.
6. If the institution contravenes any of the above conditions or any of the provisions of the NCTE Act, Rules, Regulations and Orders made or issued thereunder, the Regional Committee may withdraw the recognition under the provisions of Section 17(1) of the NCTE Act.
