Order

In terms of Section 14(1) of the NCTE Act, 1993 Centre for Advanced Study in Psychology, Utkal University, Vani vihar, Bhubaneswar, Orissa (University Deptt.), Pin – 751 004 had submitted an application to the Eastern Regional Committee of NCTE for grant of recognition for starting an innovative course P.G.DECE. of one year duration with an annual intake of 16 (Sixteen) students.

2. On scrutiny of the application submitted by the institution, the documents attached therewith, the inputs received from the visiting team, the Committee recommended the innovative course to the NCTE Hqrs. as per the guidelines No.F.49-3/2003-NCTE (N & S) dt.1.3.2004 for approval of the Chairperson, NCTE and the council vide letter dated 2.11.2004 accorded approval for the recognition of P.G.Diploma in Early Childhood Education (PGDECE) course.

3. Now, therefore, in exercise of the powers vested under Section 14(3) (a) of the NCTE Act, 1993, hereby grants recognition to Centre for Advanced Study in Psychology, Utkal University, Vanivihar, Bhubaneswar, Orissa (University Deptt.), Pin – 751 004 for P.G.DECE Course of one year duration which is an innovative course from the academic session 2004-2005 with an annual intake of 16 (sixteen) students subject to fulfillment of the following:


- a) The institution will ensure that Head and faculty members duly approved by the affiliating University i.e Registrar, Utkal University are in position for an intake of 16 students before the commencement of the course and a report to this effect shall be sent to the Eastern Regional Committee.
- b) The institution shall comply with the various other norms and standards prescribed in the NCTE regulations.

4. Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC, the State Government etc.

5. The institution shall submit to the Regional Committee a Performance Appraisal Report at the end of each academic year along with a copy of the approval of the affiliating University to the appointment of faculty members, and the statement of annual accounts duly audited by a Chartered Accountant.

6. If the institution contravenes any of the above conditions or any of the provisions of the NCTE Act, Rules, Regulations and Orders made or issued thereunder, the Regional Committee may withdraw the recognition under the provisions of Section 17(1) of the NCTE Act.
