WHEREAS, in terms of Section 14(1) of the NCTE Act, 1993, Institute of Advanced Studies in Education, Kunjaban, Agartala, West Tripura, Tripura- 799006 (Code No. APE00335) was granted recognition for conducting M.Ed.(Part-time) course vide Order No. ERC/7-46(ER-46.5.5)/2004/2058 dated 09.04.2007 with 40 intake from the academic session 2004-2005 by the ERC, NCTE, followed by revised order dated 31.05.2015 with 50 intake (one basic unit) from the academic session 2015-2016 inadvertently issued, which is found irregular as per NCTE Regulations, 2014.

AND WHEREAS, the matter was considered by the ERC in its 266th meeting held on 31st Janaury, 2019 and decided as under:

"The Committee is of the opinion that recognition granted to M.Ed.(Part-time) course of the application bearing Code No. APE00335 is withdrawn under section 17(1) of NCTE Act, 1993."

- NOW THEREFORE, recognition granted to Institute of Advanced Studies in Education, Kunjaban, Agartala, West Tripura, Tripura- 799006 (Code No.APE00335) for conducting M.Ed.(Part-time) Course is hereby withdrawn in terms of Section 17(1) of NCTE Act, 1993.
