Order

In exercise of the powers vested under Section 14(3) (a) of the National Council for Teacher Education (NCTE) Act, 1993, the Eastern Regional Committee grants recognition to College of Teacher Education, Kunjaban, Agartala, Tripura-799 006 (Tripura) for M.Ed. Course of one year duration from the academic session 2001-2002 with an annual intake of 10 (Ten) students, subject to fulfilling the following conditions:

1. Five teachers qualified as per NCTE norms should be exclusively engaged for M.Ed. course.
2. The existing 2 teacher appointed after 17.8.95 and not qualified as per NCTE norms shall acquire qualifications by 31.12.2001.
3. The institution shall ensure library, laboratories and other instructional infrastructure as per the NCTE norms.
4. Number of books in the library and journals subscribed should be subscribed as per NCTE norms.
5. The admission to the approved course shall be given only to those candidates who are eligible as per the regulations governing the course and in the manner laid down by the affiliating university/ State Government.
6. Tuition fee and other fees will be charged from the students as per the norms of the affiliating university/State Government till such time NCTE regulations in respect of fee structure come into force.
7. Curriculum transaction, including practical work/activities, should be organised as per the norms and standards for the course and the requirements of the affiliating university/examining body.
8. Teaching days including practice teaching should not be less than the number fixed in the NCTE norms for the course.
9. The institution shall continue to fulfil the norms laid down under the regulations of the NCTE and submit to the Regional Committee the Annual Report and the Performance Appraisal Report at the end of each academic year. The Performance Appraisal Report should inter alia give the extent of compliance of the conditions indicated at 1 to 8 above.

If College of Teacher Education, Kunjaban, Agartala, Tripura-799006 (Tripura) contravenes the provisions of the NCTE Act or the rules, regulations and orders made or issued thereunder or fails to fulfil the above conditions, the Regional Committee may withdraw this recognition under the provisions of Section 17(1) of the NCTE Act.


