### **ORDER**

WHEREAS, Institute of Advanced Studies in Education, Kunjaban, Agartala, West Tripura, Tripura-799006 (Code No. TR-S/N-1/99) was granted recognition for M.Ed. course with an intake of 50 from the academic session 2001-2002 vide ERC order No. ERC/7-18/2001/1510(1) dated 23.05.2001, followed by revised order vide No.31689 dated 15.05.2015 from the academic session 2015-2016 as per NCTE Regulations, 2014 subject to fulfilment of the conditions in respect of enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintain and update website and to comply the same to the ERC.

- 2. **AND WHEREAS**, the ERC in its  $254^{th}$  meeting held on  $16^{th}$   $17^{th}$  April, 2018 considered the matter and as decided, Show Cause Notice u/s 17(1) was issued on 20.04.2018 to the institution on the following grounds:
  - a. Approved faculty list (current) by the concerned affiliating body along with requisite documents.
  - b. Approved building plan by the concerned competent Govt.
    Engineer/Authority.
  - c. Approved building completion certificate by the concerned competent Govt. Engineer/Authority.
  - d. FDRs towards Endowment fund and Reserve fund after conversion into joint operation mode as prescribed in the NCTE Regulations, 2014.
  - e. Confirmation on website updates of the institutions with all details along with affidavit.
- 3. **AND WHEREAS**, the ERC in its 271st Meeting held on 24th 25th April, 2019 considered the matter and as decided, Show Cause Notice u/s 17(1) of NCTE Act, 1993 by ERC, NCTE dt. 18.05.2019 for compliance regarding fulfilment of the conditions in respect of enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintain and update website as mentioned in the Revised Recognition Order. However, the concerned institutions have failed to submit reply of Show Cause Notice within the stipulated period of 21 days.
- 4. AND WHEREAS, the ERC in its  $274^{th}$  Meeting held on  $15^{th}$   $16^{th}$  July, 2019 considered the matter and as decided, 1st show cause notice u/s 17(1) issued on 20.04.2018, followed by final show cause notice dated 18.05.2019 on the following grounds:
  - a. Approved faculty list by the concerned affiliating body along with requisite documents.

- b. Approved building plan by the concerned competent Govt. Engineer/Authority.
- c. Approved building completion certificate by the concerned competent Govt. Engineer/Authority.
- d. FDRs towards Endowment fund and Reserve fund after conversion into joint operation mode as prescribed in the NCTE Regulations, 2014.
- e. Confirmation on website updates of the institutions with all details along with affidavit.

No reply received and the stipulated time period has already been over.

Recognition granted to M.Ed. course is withdrawn under section 17(1) of NCTE Act, 1993 from the academic session 2020-2021.

- 5. NOW THEREFORE, recognition granted to the institution viz. Institute of Advanced Studies in Education, Kunjaban, Agartala, West Tripura, Tripura-799006 (Code No.TR-S/N-1/99) for M.Ed. Course is hereby withdrawn under section 17(1) of NCTE Act, 1993 with effect from the end of the academic session next following the date of communication of such order i.e. from 2020-2021.
- 6. **FURTHER**, if the institution is not satisfied by the order, they can prefer an appeal Under Section 18 of the NCTE Act in the "Online mode" available on NCTE's website <a href="https://www.ncte-india.org">www.ncte-india.org</a> within 60 days from the date of the issue of the order.
