**ORDER**

**WHEREAS**, in terms of Section 15(1) of the NCTE Act, 1993, Gour Chandra Memorial Trust, Plot No - 389, Village - Galia, P.O. - Galia, Tehsil/Taluka - Joypur, Town/City- Bishnupur, Dist. - Bankura, West Bengal - 722154 has applied for grant of permission to **Spandan College of Education, Plot No- 389, Village - Katul, P.O. - Belsul, Tehsil/Taluka - Joypur, Town/City- Bishnupur, Dist. - Bankura, West Bengal - 722122 (Code No. ERCAPP3582)** for **Additional Intake of B.Ed Course** online on **25.06.2015** for two year duration and hard copy received by Eastern Regional Committee of NCTE on **08.07.2015**.

2. **AND WHEREAS**, on scrutiny of the application submitted by the institution, the documents attached therewith, the affidavit submitted and the report received from VT and videography, and the certificates received from the affiliating body, the Committee is satisfied that the applicant fulfils the requirements under the provisions of NCTE Act, Rules and relevant Regulations including the Norms and Standards for the said teacher education programme such as instructional facilities, infrastructural facilities, financial resources, etc., for running the programme.

3. **AND WHEREAS**, as per the decision of 213<sup>th</sup> ERC meeting held on 29<sup>th</sup> - 30<sup>th</sup> April & 1<sup>st</sup> - 2<sup>nd</sup> May 2016, formal recognition order under clause 7(16) was issued vide No. 46512 dated 02.05.2016 with an **intake 50 (one basic unit)** from the academic session **2016-17** to the institution.

4. **AND WHEREAS**, the institution preferred an appeal to the NCTE Hqrs. against the ERC's order dated 02.05.2016. The Appellate Authority vides Order No. 89-373/2016-Appeal/12<sup>th</sup> Meeting-2016 dated 26.09.2016 remanded back the case to ERC for revisiting the matter and modifying the recognition order suitably for grant of 2 units of B.Ed. course.

Thereafter, the ERC re-viewed the matter in accordance with the appeal order and observed as under:-

- (i) The institution appointed 16 faculties for granting 2 units for the applied B.Ed. course.
- (ii) The committee found that all 16 faculties are qualified as per NCTE Regulations, 2014.

**In view the above, the committee decided as under:**

The ERC considered the direction of Appeal Committee and keeping in view, the direction of the Hon<sup>ble</sup> Supreme Court of India for granting recognition for the session 2016-2017 was 2<sup>nd</sup> May, 2016 which has already been over. Therefore, the ERC considered the case and decided to issue formal permission order as on date for another one unit (Additional intake) in B.Ed. course from the session 2017-2018 be issued to the institution.

5. **NOW THEREFORE**, in exercise of the powers vested under Section 15(3)(a) of the NCTE Act 1993, the Eastern Regional Committee, NCTE hereby grants permission to **Spandan College of Education, Plot No- 389, Village - Katul, P.O. - Belsul, Tehsil/Taluka - Joypur, Town/City- Bishnupur, Dist. - Bankura, West Bengal - 722122** for conducting **B.Ed Course** of two years duration with an additional intake of 50 students (additional one unit), (existing 50 intake + additional 50 intake), thus making the **total intake of 100 (one hundred)** from the academic session **2017-2018** under Clause 7(16) of NCTE (Recognition Norms & Procedure) Regulations, 2014 subject to fulfillment of the following conditions:-

- I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Loan raising against or mortgaging of FDRs shall not be done.
- II. The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.
- III. The institution shall make admission only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations 2014.
- IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.

6. Further, the recognition/permission is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University / Body, the State Government etc, as applicable.

7. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.

8. The institution shall maintain its website with hyperlink to the Council and the Eastern Regional Committee, covering, inter-alia, the details of the institution, its location, name of the programme applied for with intake; availability of physical infrastructure, such as land, building, office, classrooms and other facilities or amenities; instructional facilities, such as laboratory and library and the particulars of their proposed teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website, namely:-

- a) Sanctioned programmes along with annual intake in the institution;
- b) Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph;
- c) Name of faculty members who left or joined during the last quarter;
- d) Names of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
- e) Fee charged from students;
- f) Available infrastructural facilities;
- g) Facilities added during the last quarter;
- h) Number of books in the library, journals subscribed to, and additions, if any, in the last quarter;
- i) The affidavit with enclosure submitted along with application;
- j) The institution shall be free to post additional relevant information, if it so desires.

- k) Any false or incomplete information on its website shall render the institution liable for withdrawal of recognition.
9. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
10. The institution shall make available list of students admitted on its official website.
11. The Educational Institution shall follow Uniform Accounting System as brought out by ICAI and accepted by MHRD.
12. If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made and issued there under, the institution will render itself liable to adverse action including withdrawal of recognition / permission by the Regional Committee under the provisions of Section 17(1) of the NCTE Act.
