### <u>ORDER</u>

WHEREAS, Department of Education, University of Calcutta, 1, Reformatory Street, Alipore,Kolkata, West Bengal-700027 (APE00036) was granted recognition for B:Ed. course with an intake of 130 from the academic session 2002-2003 vide ERC's Order No. 1858 dated 20.06.2002, followed by revised recognition order vide No. 32595 dated 31.05.2015 with an intake of 50 from the academic session 2015-2016 as per NCTE Regulations, 2014 subject to fulfilment of the conditions in respect of enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintain and update website and to comply the same to the ERC.

2. **AND WHEREAS**, the ERC in its  $267^{\text{th}}$  Meeting held on  $10^{\text{th}} - 11^{\text{th}}$  February, 2019 considered the matter and Show Cause Notice u/s 17(1) was issued on 21.02.2019 to the institution.

3. AND WHEREAS, the institution had failed to submit reply in response to SCN dated 21.02.2019 within stipulated period. The ERC in its  $272^{nd}$  Meeting held on  $30^{th} - 31^{st}$  May &  $1^{st}$  June, 2019 considered the matter and another Show Cause Notice u/s 17(1) was issued on 14.06.2019 to the institution.

4. **AND WHEREAS**, the institution has submitted reply dated 26.06.2019 received in this office on 03.07.2019. The ERC in its 275<sup>th</sup> meeting held on 27<sup>th</sup> July, 2019 considered the matter and Final Show Cause Notice u/s 17(1) was issued on 11.09.2019 to the institution on the following grounds:

- (i) Faculty list is not as per NCTE Regulations, 2014. Besides Head, faculty comprises 05 against the requirement of 07 for running 50 intake of B.Ed. course.
- (ii) Faculty list is not in NCTE prescribed proforma and not approved by concerned affiliating body.
- (iii) Building plan and building completion certificate are not approved by competent Govt. Engineer.
- (iv) Financial transaction not monitored by affiliating body Department.

5. AND WHEREAS, the institution has submitted reply dated 09.09.2019 received in this office on 16.09.2019. The ERC in its  $279^{th}$  Meeting held on  $14^{th} - 16^{th}$  February, 2020 considered the original file of the institution along with other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, were carefully considered by ERC and the following observation was made:-

- (i) Building Completion Certificate (BCC) duly signed by the competent authority in the prescribed proforma is not submitted.
- (ii) Requisite information of the institutional website has not updated as per clause 7(14)(i) of the NCTE Regulation, 2014.
- (iii) Faculty list duly approved by the competent authority as per NCTE Regulation, 2014 is not submitted.

Hence, B.Ed. course is withdrawn under section 17(1) of NCTE Act, 1993 from the next academic session 2020-21.
