ERC/NCTE/(APE01008)/B.Ed.(Revised Order)/ 2015/ 31950 dated 23.05.2015 for conduct of B.Ed. course of two years duration with an intake of 100 for Two Basic Units of 50 students each from the academic session 2015-2016.

Whereas a representation dated 16.01.2015 has been received from the President, Tribir Kumar Das requesting for withdrawal of recognition of Raja Rammohan Ray College of Education (B.Ed), Vill- Adampur, PO- Mahadevpur, Dist-Malda, West Bengal-732121 as the Unviersity of Gour Banga has withdrawn affiliation.
- 4. Whereas the matter was placed before the ERC in its 184^{th} meeting held on 24^{th} 25^{th} March 2015 and the ERC considered the matter and decided as under:-
 - The institution is directed to submit the certifying copy of the minutes/ resolution of the Board of Trustees, NOC from the affiliating body, Affidavit about no dues for withdrawal of the application.
- 5. Whereas a representation dated 13.04.2015 received from President, Sukdeb Biswas in response to the 184th ERC decision. The President, Sukdeb Biswas in its representation stated that he had never submitted before ERC-NCTE any representation regarding withdrawal of recognition of the college nor management committee of the college or the sponsoring society of the college.
- 6. Whereas the representation dated 13.04.2015 was placed before the ERC in its 186th meeting held on 23rd 24th April 2015. The Eastern Regional Committee in its 186th meeting decided as under:
 - The above two representations of the institution my be forwarded to the Concerned Unvieristy & concencerned State Govt, and the institution to apprise the real situation to ERC, NCTE immediately for appropriate action.
 - No admission to be taken for any course by the institution till the clarification received from the institution, University and State Govt. or till further communication from ERC.

- 7. AND WHEREAS letter to the institution, concerned University and concerned state govt, was issued as per the decision of 186th meeting. No reply from the concerned University and concerned state govt, received within the requested time.
- 8. AND WHEREAS the President, Tribir Kumar Das vide its representation dated 26.06.2015 again requested for withdrawal of recognition of the institution viz. Raja Rammohan Ray College of Education (B.Ed), Vill- Adampur, PO- Mahadevpur, Dist-Malda, West Bengal-732121.
- 9. AND WHEREAS the representation received from the President, Tribir Kumar Das was again placed before the ERC in its 191st meeting held on 14-15 July 2015. The Eastern Regional Committee in its 191st meeting considered the representation dated 26.06.2015 of the President, Shri Tribir Kumar Das and decided as under:
 - The President of the institution requested to withdraw the recognition. The Committee
 accepted the request of the institution and decided to withdraw the recognition of the
 institution for B.Ed. Course from the session 2015-2016.
- 10. NOW, THEREFORE, grant of recognition to Raja Rammohan Ray College of Education (B.Ed), Vill- Adampur, PO- Mahadevpur, Dist-Malda, West Bengal-732121 (Code No. APE001008) for B.Ed. course is hereby withdrawn from the academic session 2015-2016.
- 11. Further, if the institution is not satisfied with the order, they may prefer an appeal under Section 18 of the NCTE Act in the "Online mode" available at NCTE's website www.ncte-india.org within 60 days of the issue of the order.
