## ORDER

WHEREAS, Sponsored Teachers' Training College, Deshbandhu Road, Dist.- Purulia, West Bengal- 723101 (Code No. APE00221) was granted recognition for conducting B.Ed. course with an intake of 100 from the academic session 2003-2004 vide ERC order dated 11.08.2003, followed by revised order dated 25.05.2015 from the academic session 2015-2016 as per NCTE Regulations, 2014 subject to fulfilment of the conditions in respect of enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintain and update website and to comply the same to the ERC.

2. **AND WHEREAS**, the ERC in its 275<sup>th</sup> (Part-1) meeting held on 26<sup>th</sup> July, 2019 considered the matter and observed that 1<sup>st</sup> show cause notice u/s 17(1) issued on 21.02.2019 and the Committee has observed the following:-

- (i) Faculty comprises 1+9 instead of 1+15 as per NCTE Regulations, 2014 for running 100 intake of B.Ed. course.
- (ii) The institution has requested to reduce the intake by 50 from 100 seats as the institution has expressed its inability to recruit specified faculty members i.e. 15.

Based on the request of the institution, the intake for B.Ed. course be reduced from 100 to 50 from the current academic session with intimation to the institution and all concerned.

3. NOW THEREFORE, recognition granted to the institution viz. Sponsored Teachers' Training College, Deshbandhu Road, Dist.- Purulia, West Bengal-.723101 (Code No. APE00221) for conducting B.Ed. Course is hereby reduced intake from 100 to 50 (One basic unit) from the current academic session.
