### ORDER

WHEREAS, Scottish Church Colleg, 1 & 3, Urquhart Square, Beadon Street, Kolkata, West Bengal - 700006 (Code No. APE00245) was granted recognition for B.Ed. course with an intake of 100 from the academic session 2004-2005 vide ERC Order No. 3145 dated 02.11.2004, followed by revised order vide No. 32387 dated 29.05.2015 with an annual intake of 50 from the academic session 2015-2016 as per NCTE Regulations, 2014 subject to fulfilment of the conditions in respect of enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintain and update website and to comply the same to the ERC.

AND WHEREAS, the ERC in its 275<sup>th</sup> held on 26<sup>th</sup> July, 2019 considered the matter and as decided, Show Cause Notice u/s 17(1) was issued on 11.09.2019 to the institution on the following grounds:

- Faulty list comprises 1+9 instead of 1+15 as per NCTE Regulations, 2014.
- (ii) Out of 9 faculties four on contractual basis are not accepted.
- (iii) Submitted building plan in small font and illegible.
- (iv) Building completion certificate is not in NCTE prescribed proforma and not approved (v) FDRs towards Endowment and Reserve Fund not maintained as per procedure under
- NCTE Regulations, 2014.

AND WHEREAS, the ERC in its  $278^{th}$  Meeting held on  $16^{th} - 18^{th}$  January, 2020 considered the matter along with the reply received on 03.10.2019 submitted by the institution in response to Show Cause Notice and observed as under:-

a) Approved faculty list as per NCTE Regulations, 2014 has not been submitted.

In view of the above, the Committee decided as under:

Hence, B.Ed. course is withdrawn under section 17(1) of NCTE Act, 1993 from the next academic session 2020-2021.

NOW THEREFORE, recognition granted to the institution viz. Scottish Church Colleg, 1 & 3, Urquhart Square, Beadon Street, Kolkata, West Bengal - 700006 (Code No.APE00245) for B.Ed. Course is hereby withdrawn under section 17(1) of NCTE Act, 1993 with effect from the academic session 2020-2021.
