3. **AND WHEREAS**, the letter was not issued to the institution and the matter was re-considered by ERC in its 274th meeting held on 15th – 16th July, 2019 under the agenda item No. 272.14.57 before confirmation of proceedings of 272nd ERC meeting.

4. **AND WHEREAS**, the ERC in its 274th meeting held on 15th – 16th July, 2019 rectified with following observation:-

In the submitted approved list of faculty by affiliating body received from Govt. of West Bengal, faculty comprises 09 regular (1 Principal + 8 lecturers) only. The institution is entitled for running one unit (50 intake) of B.Ed. course as per NCTE Regulations, 2014.

The intake for **B.Ed. course** be **reduced from 100 to 50** from the academic session **2020-2021** with intimation to the institution and all concerned.
