## ORDER

WHEREAS, Dr. B.R. Ambedkar College, Vill.-& P.O.- Malighati, P.S.- Debra, Dist.-Paschim Medinipur, West Bengal-721211 (Code No. APE00317) was granted recognition for B.Ed. course with an intake of 100 from the academic session 2014-2015 vide ERC Order No. 3835 dated 31.10.2006, followed by revised order vide No.31927 dated 23.05.2015 an intake of 100 from the academic session 2015-2016 as per NCTE Regulations, 2014 subject to fulfilment of the conditions in respect of enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintain and update website and to comply the same to the ERC.

2. AND WHEREAS, Recognition of B.Ed. Course (100 intakes) is refused vide Order No. 59485 dated 22.09.2019 as per the decision of 266<sup>th</sup> ERC meeting held on 25<sup>th</sup> -26<sup>th</sup> March, 2019 on the following grounds:-

- Show Cause Notice u/s 14(3)(b) were issued on 23.08.2018 for submission of fire safety certificate issued from the competent Govt. Authority.
- The institution vide letter dated 09.10.2018 expressed inability to submit the fire safety certificate.
- The institution is still deficient on the above ground.

3. AND WHEREAS, the institution has preferred an appeal Order No. F.No.89-87/E-109810/2019Appeal/28<sup>th</sup> Mtg.-2019/28<sup>th</sup> August, 2019/82386 dated 26/09/2019 against the ERC refusal order dated 22.09:2019 but the appeal committee decided to confirm the impugned refusal order dated 22.03:2019.

4. AND WHEREAS, the institution filed MAT 1822 of 2019 with CAN 11851 of 2019 filed by The West Bengal University of Teachers Training Education Planning and Administration & Anr. Vs. Abhradeep Pan & Ors. The Regional Director, NCTE. Eastern Regional Committee shall take note of the Fire Safety Certificate dated 10<sup>th</sup> September, 2019 and shall pass an appropriate order with regard to the renewal of recognition of the college for the session 2019 within three weeks from the date. The said Authority, if required, may call for an authenticated copy of the certificate dated 10<sup>th</sup> September, 2019 from the Director General, West Bengal fire and Emergency Services for satisfaction. It is needless to mention that once the Regional Committee is satisfied with the Certificate, the order of deaffiliation by the University stands automatically recalled.
