ORDER

WHEREAS, Dr. B. R. Ambedkar College, Vill/PO.- Mallighati, PS.- Debra, Dist.- Paschim Medinipur, West Bengal-721211 (APE00317) was granted recognition by ERC, NCTE vide Order No. ERC/7-70.6.2/2006/3835 dated 31.10.2006 for conducting B.Ed. Course with an annual intake of 100 from the academic session 2006-2007, followed by revised order issued vide No. 31927 dated 23.05.2015 as per NCTE Regulation, 2014.

AND WHEREAS, the ERC in its 233rd meeting held on 17th -18th February 2017 after considered 2. the representation dated 03.01.2017 along with letter dated 02.01.2017 received from Sh. Sachindra Nath Mishra, Secretary of the Malighati Dr. B.R. Ambedkar Society for Advancement of Learning and Health, Paschim Medinipur, West Bengal requesting to withdraw the B.Ed. course from the academic session 2017-2018 as the institution is unable to comply the Norms & Standards of NCTE relating to land and building, qualified Principal & lecturers, Endowment & Reserve fund, Audited Accounts, Infrastructure & Website etc.

In view the above, the committee decided as under:

The committee accepted the request of the institution and decided that the recognition of the institution for B.Ed. course be withdrawn from the academic session 2017-2018 and copy of the withdrawal order be endorsed to the concerned State Government as well as affiliating body.

3. NOW, THEREFORE, grant of recognition to Dr. B. R. Ambedkar College, Vill/PO.- Mallighati, PS- Debra, Dist.- Paschim Medinipur, West Bengal-721211 (Code No. APE00317) for B.Ed. course is hereby withdrawn from the academic session 2017-2018 in terms of section 17(1) of NCTE Act, 1993.

4. Further, if the institution is not satisfied with the order, they can prefer an appeal under Section 18 of the NCTE Act in the "Online mode" available at NCTE's website www.ncte-india ore within 60 days from the date of issue of the order.
