**ORDER**

WHEREAS, Nikhil Banga Sikshan Mahavidyalaya, P.o.- Bishnupur, Dist.- Bankura, West Bengal - 722122 (Code No. APE00336) was granted recognition for B.Ed. course with an intake of 100 from the academic session 2008-2009 vide ERC Order No. 6994 dated 12.03.2007, followed by revised order vide No. 32250 dated 27.05.2015 from the academic session 2015-2016 as per NCTE Regulations, 2014 subject to fulfilment of the conditions in respect of enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintain and update website and to comply the same to the ERC.

2. AND WHEREAS, the ERC in its 267<sup>th</sup> meeting held on 10<sup>th</sup> - 11<sup>th</sup> February, 2019 considered the matter and as decided, Show Cause Notice u/s 17(1) was issued on 21.02.2019 to the institution on the following grounds:

- Approved faculty list (current) by the concerned affiliating body along with requisite documents.
- Approved building plan by the concerned competent Govt. Engineer/Authority.
- Approved building completion certificate by the concerned competent Govt. Engineer/Authority.
- FDRs towards Endowment fund and Reserve fund after conversion into joint operation mode as prescribed in the NCTE Regulations, 2014.
- Confirmation on website updates of the institutions with all details along with affidavit.

3. AND WHEREAS, the ERC in its 275<sup>th</sup> Meeting held on 26<sup>th</sup> July, 2019 considered the matter along with the reply dated 19.08.2019 submitted by the institution in response to Final Show Cause Notice u/s 17(1) was issued on 11.09.2019 to the institution on the following grounds:


- Faculty viz. Aravinda Dey appointed for English subject on part-time is not accepted.
- FDRs towards Endowment and Reserve Fund are not submitted.

4. AND WHEREAS, the ERC in its 278<sup>th</sup> Meeting held on 16<sup>th</sup> - 18<sup>th</sup> January, 2020 considered the matter along with the reply received on 02.09.2019 submitted by the institution in response to Show Cause Notice and observed as under:-

- List of teaching faculty submitted by the institution is not as per Appendix-4 of NCTE, Regulation, 2014.

In view of the above, the Committee decided as under:

Hence, B.Ed. course is withdrawn under section 17(1) of NCTE Act, 1993 from the next academic session 2020-2021






