  - (iii) Approved building completion certificate by the concerned competent Govt. Engineer/ Authority.
  - (iv) FDRs towards Endowment fund and Reserve fund after conversion into joint operation mode as prescribed in the NCTE Regulations, 2014.
  - (v) Confirmation on website updates of the institutions with all details along with affidavit.
- AND WHEREAS, the ERC in its 275th Meeting held on 26th July, 2019 considered the matter along with the reply dated 19.08.2019 submitted by the institution in response to Final Show Cause Notice u/s 17(1) was issued on 11.09.2019 to the institution on the following grounds:
  - a) Faculty viz. Aravinda Dey appointed for English subject on part-time is not accepted.
  - b) FDRs towards Endowment and Reserve Fund are not submitted.
- AND WHEREAS, the ERC in its 278<sup>th</sup> Meeting held on 16<sup>th</sup> 18<sup>th</sup> January, 2020 considered the matter along with the reply received on 02.09.2019 submitted by the institution Show Notice response to Cause observed under:in
  - c) List of teaching faculty submitted by the institution is not as per Appendix-4 of NCTE, Rengulation, 2014.
