<u>ORDER</u>

WHEREAS, Swami Vivekananda College of Education for Women, 20, Riverside Road, P.O. Barrackpore, North 24 Parganas, West Bengal – 700120 (B.Ed.) (APE00532) was granted recognition for B.Ed. course with an intake of 100 vide ERC's Order No. 8181 dated 24.05.2007, followed by revised recognition order vide No. 31976 dated 23.05.2015 with an intake of 100 from the academic session 2015-2016 as per NCTE Regulations, 2014 subject to fulfilment of the conditions in respect of enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintain and update website and to comply the same to the ERC.

2. AND WHEREAS, the ERC in its 267^{th} Meeting held on $10^{\text{th}} - 11^{\text{th}}$ February, 2019 considered the matter and Show Cause Notice u/s 17(1) was issued on 21.02.2019 to the institution.

3. **AND WHEREAS**, the institution had failed to submit reply in response to SCN dated 21.02.2019 within stipulated period. The ERC in its 277^{th} Meeting held on $19^{\text{th}} - 20^{\text{th}}$ Dec, 2019 considered the matter and Final Show Cause Notice u/s 17(1) was issued on 26.12.2019 to the institution.

(i) No reply has been received against the first show cause notice issued on 21.02.2019.

4. **AND WHEREAS**, the institution has submitted reply dated 13.01.2020 received in this office on 15.01.2020. The ERC in its 279^{th} Meeting held on $14^{th} - 16^{th}$ February, 2020 considered the original file of the institution along with other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, were carefully considered by ERC and the following observation was made:-

- (i) FDRs of Rs.5 lakh and Rs.7 lakh is not submitted.
- (ii) The khata No./Plot No. and total built up area earmarked for the course duly signed by the competent authority is not submitted.
- (iii) Building Completion Certificate (BCC) in the prescribed proforma mentioning the khata No./Plot No. and total built up area duly signed by the competent authority is not submitted.

Hence, B.Ed. course is withdrawn under section 17(1) of NCTE Act, 1993 from the next academic session 2020-21. \int_{1}^{1}
