## <u>ORDER</u>

WHEREAS, Vivekananda Teachers Training College, Vill.- Chandipur, P.O.- Kazigram, Dist.- Malda, West Bengal- 732101 (Code No. APE00533) was granted recognition for B.Ed. course with an intake of 100 vide ERC Order No.7918 dated 22.05.2007, followed by revised order vide No.32053 dated 24.05.2015 from the academic session 2015-2016 as per NCTE Regulations, 2014 subject to fulfilment of the conditions in respect of enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintain and update website and to comply the same to the ERC.

2. **AND WHEREAS**, the ERC in its 269<sup>th</sup> (Part-II) meeting held on 02<sup>nd</sup> – 03<sup>rd</sup> March, 2019 considered the reply dated 27.10.2015 in response to revised recognition order submitted by the institution along with letter dated 04.04.2017 from University of Gour Banga, West Bengal and observed as under:

(i) The college has been de-affiliated by University of Gour Banga, Malda, West Bengal, as intimated vide letter Ref. No.210/UGB/CE-17 dated 04.04.2017 by Controller of Examination (Addl. Charge) of the concerned University.

In view of the above, the Committee decided as under:

The Committee is of the opinion that recognition granted to B.Ed. course of the application bearing Code No. APE00533 is withdrawn under section 17(1) of NCTE Act, 1993 with effect from the academic session 2019-2020."

Accordingly, withdrawal order u/s 17(1) was issued vide No.ER-269.14.6(Part-II)/ APE00533/B.Ed./2019/59671 dated 03.03.2019 to the institution and all concerned.

3. **AND WHEREAS**, the institution has submitted representation vide Ref. No.VTTC-01/NCTE-19 dated 07.03.2019 enclosing the following documents apart from others:

- (i) A copy of Notification vide No.90-Edn(U)/1U(WBUTTE)-11/15 dated 30.01.2017 issued by Department of Higher Education, Science & Technology and Biotechnology, University Branch, Government of West Bengal relating to change of jurisdiction of the affiliating body from 'Gour Banga University' to 'The West Bengal University of Teachers Training, Education Planning and Administration'.
- (ii) A copy of letter vide No.WBUTTEPA/RO/AFFL/258/2017 dated 11.05.2017 relating to grant of affiliation to the institution by The West Bengal University of Teachers Training, Education Planning and Administration with effect from the academic session 2017-2018.

AND WHEREAS, the ERC in its 270<sup>th</sup> meeting held on 25<sup>th</sup> – 26<sup>th</sup> March, 2019 considered the matter for review their earlier decision taken by ERC in 269th (Part-II) meeting and observed that the letter of de-affiliation issued by University of Gour Banga, Malda, West Bengal vide Ref. No.210/UGB/CE-17 dated 04.04.2017 is after the issuance of Notification dated 30.01.2017 regarding change of affiliating body by Govt. of West Bengal, hence, the letter of de-affiliation cannot be considered. Moreover, the institution has also been granted affiliation on 11.05.2017 by the new affiliating body i.e. The West Bengal University of Teachers Training, Education Planning and Administration.

In view of the above, the Committee decided as under: The Committee is of the opinion that recognition withdrawn to B.Ed. course vide order dated 03.03.2019 be restored with effect from the academic session 2019-2020, accordingly order be issued.

NOW THEREFORE, recognition granted to the institution viz. Vivekananda Teachers Training College, Vill.- Chandipur, P.O.- Kazigram, Dist.- Malda, West Bengal- 732101 is hereby restored with effect from the academic session 2019-2020 and withdrawal order has been treated as cancelled.
