## **ORDER**

WHEREAS, Gangarampur B.Ed. College, P.O. Kaldighi, P.S. Gangarampur, Dist. Dakshin Dinajpur, West Bengal-733124 (Code NoAPE00551) was granted recognition for B.Ed. course with an intake of 100 from the academic session 2007-2008 vide ERC Order No. 4958 dated 15.12.2006, followed by revised order vide No.332046 dated 24.05.2015 an intake of 100 from the academic session 2015-2016 as per NCTE Regulations, 2014.

- 2. AND WHEREAS, Recognition grated to B.Ed. Course was Withdrawn vide Order No. 60151 dated 10.04.2019 as per the decision of 268th ERC meeting held on 24th - 25th February. 2019 on the following grounds:-
  - Show Cause Notice were issued on 15.05.2018 and 22.01.2019.
  - Faculty list comprising 1+10 instead of 1+15 as per NCTE Regulations, 2014.
  - The institution is still deficient in compliance of appointment of required faculty. No more extension of times is allowed by the Committee.
- AND WHEREAS, the institution has preferred an appeal Order No. F.No.89-202/E-118235/2019 Appeal/18th Mtg.-2019/13th June,2019/80686 dated 16.07.2019 against the ERC withdrawn order dated 10.04.2019 but the appeal committee decided that the mater deserved to be remanded to the ERC with a direction to consider the approved faculty list, to be submitted to them by the appellant, and take further action as per the CNTE Regulations, 2014. The appellant is directed to forward to the ERC approved faculty list within 15 days of receipt of order on the appeal.
- AND WHEREAS, the institution has submitted representation dated 06.08.2019 received in this office on 13.08.2019. The ERC in its 277<sup>th</sup> meeting held on 19<sup>th</sup> - 20<sup>th</sup> Dec, 2019 considered the matter and as decided, Show Cause Notice was issued on 26.12.2019 to the institution.
- 5. AND WHEREAS, the institution has submitted reply vide letter dated 03.01,2020 received in this office on 10.01.2020. The ERC in its 280th meeting held on 29th February & 1st March 2020 considered the matter and as decided, Final Show Cause Notice was issued on 03.03.2020 to the institution on the following grounds:-
  - Requisite information of the institutional website has not updated as per (iii) clause 7(14)(i) of the NCTE Regulation, 2014.

7. NOW, THEREFORE, recognition withdrawn vide order dated 10.04.2019, Gangarampur B.Ed. College, P.O. Kaldighi, P.S. Gangarampur, Dist. Dakshin Dinajpur, West Bengal-733124 (Code No. EAPE00551) for B.Ed. course is hereby restored.
