## <u>ORDER</u>

WHEREAS, Cooch Behar B.Ed. Training College, P.O.- Tangonmari (Rajarhat), Dist.- Cooch Behar, West Bengal- 736101 (APE00552) was granted recognition for conducting B.Ed. course with an intake of 100 vide ERC order No.6217 dated 09.02.2007, followed by revised order vide No.31931 dated 23.05.2015 from the academic session 2015-2016 as per NCTE Regulations, 2014 subject to fulfilment of the conditions in respect of enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintain and update website and to comply the same to the ERC.

2. **AND WHEREAS**, the ERC in its 275<sup>th</sup> (Part-2) meeting held on 27<sup>th</sup> July, 2019 considered that 1<sup>st</sup> show cause notice u/s 17(1) issued on 21.02.2019. Final show cause notice issued dated 17.06.2019 and the institution is still deficient on the following grounds:-

(i) Building plan approved by Govt. Engineer is not submitted.

(ii) Principal and two faculty members required as per NCTE Regulations, 2014 are not appointed.

(iii) Request of the institution for extension of time is not accepted.

Recognition granted to B.Ed. course is withdrawn under section 17(1) of NCTE Act, 1993 from the academic session 2020-2021.

3. NOW THEREFORE, recognition granted to the institution viz. Cooch Behar B.Ed. Training College, P.O.- Tangonmari (Rajarhat), Dist.- Cooch Behar, West Bengal- 736101 (APE00552) for B.Ed. Course is hereby withdrawn under section 17(1) of NCTE Act, 1993 from the academic session 2020-2021.
