ORDER

WHEREAS, Eastern Dooars B.Ed. Training College, Alipurduar, Bhatibari, Dist.- Jalpaiguri, West Bengal- 736121 (APE00557) was granted recognition for conducting B.Ed. course with an intake of 100 from the academic session 2006-2007 vide ERC order No.3839 dated 31.10.2006, followed by revised order vide No.32425 dated 30.05.2015 from the academic session 2015-2016 as per NCTE Regulations, 2014 subject to fulfilment of the conditions in respect of enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintain and update website and to comply the same to the ERC.

2. **AND WHEREAS**, the ERC in its 274th meeting held on $15^{th} - 16^{th}$ July, 2019 considered that 1st show cause notice u/s 17(1) issued on 17.05.2018. Final show cause notice issued dated 11.03.2019 and the institution is still deficient on the following ground:-

(i) Photocopy of FDRs not in original and not showing in joint mode with RD, ERC, NCTE. Account No. 38410943670 found in duplicate.

In view of the above, the Committee decided as under: Recognition granted to B.Ed. course is withdrawn under section 17(1) of NCTE Act, 1993 from the academic session 2020-2021.

3. NOW THEREFORE, recognition granted to the institution viz. Eastern Dooars B.Ed. Training College, Alipurduar, Bhatibari, Dist.- Jalpaiguri, West Bengal- 736121 (APE00557) for B.Ed. Course is hereby withdrawn under section 17(1) of NCTE Act, 1993 from the academic session 2020-2021.
