WHEREAS, Swaraj Nagar Teachers Training College, PO/Sub –Division-Khatra, Dist-Bankura, West Bengal-722146 (Code No. ERCAPE00570) was granted recognition for conducting B.Ed. Course of one year duration with an annual intake of 100 (one hundred) students vide ERC order No.ERC/7-76.6(1).1/2007 dated 04.06.2007.

2. WHEREAS on the bais of complaint against the institution namely Swaraj Nagar Teachers Training College, PO/Sub –Division-Khatra, Dist-Bankura, West Bengal-722146 the Eastern Regional Committee considered the matter in its 111th meeting held on 16 & 17 September 2010, and decided to issue comments on the complaint be asked from the institution under intimation to the State Government and affiliating body before taking further action U/S 17 of the NCTE Act.

3. AND WHEREAS, the letter for comments was issued vide No.5314 Dt.05.10.2010.

4. AND WHEREAS, the reply of the institution dt.28.12.2010 received on 03.01.2011 along with the original institution file was considered by the ERC in its 119th meeting of ERC held on 16th-19th June, 2011 whereby the committee deliberated and considered the case in detail. The Committee decides that before taking final decision following documents/clarifications are required to be submitted by the institution:-

- (a) A list of qualified faculty duly appointed as per the provisions of the NCTE Regulations indicating qualification, percentage of marks, teaching experience etc. countersigned by the Registrar of affiliating university along with attested copy of professional qualification & experience certificate (as per the format enclosed).
- (b) A letter of Permanent affiliation from the Registrar of the affiliating University.
- (c) Details of salary components and salary paid to teachers as per clause 4(v)(d) of NCTE Norms for B.Ed. course with supporting documents i.e. statement towards payment of salary through bank along with a copy of a Acquittance roll of teachers showing payment of salary as per the NCTE norms.
- 5. AND WHEREAS, as per the decision of the 119th ERC meeting notice under section 17(1) of the NCTE Act. was issued vide No.7987 Dt.21.07.2011.

- 6. AND WHEREAS, the reply of the institution dt.30.06.2011 received on 11.08.2011 in response to the notice under section 17(1) of the NCTE Act. along with the original institution file was considered by the ERC in its 130th meeting of ERC held on 20th-22nd January, 2012 file was considered by the ERC^{*} in its 130th meeting of ERC held on 20th 22nd January, 2012 whereby the committee after due perusal of the reply of the institution decided as follows:
 - (a) There is discrepancy in the list submitted by the institution for the staff and list of staff being paid the salary. Therefore, in contravention of NCTE Act, the Committee decides to withdraw the recognition under section 17(1).

7. AND WHEREAS, recognition of the institution viz. Swaraj Nagar Teachers Training College, PO/Sub –Division-Khatra, Dist-Bankura, West Bengal-722146 for the B.Ed. Course in terms of Section 17(1) of the NCTE Act, 1993 was withdrawn from the academic session i.e. 2012-2013, vide order No.ERC/7-130.6(iv).1/2010/11124 Dated 14-April-2012 on the above grounds.

8. AND WHEREAS the Correspondent, Swaraj Nagar Teachers Training College, PO/Sub –Division-Khatra, Dist-Bankura, West Bengal-722146 (hereinafter referred to as the applicant), preferred an appeal dated 22.03.2012 to the National Council for Teacher Education, New Delhi (hereinafter referred to as the Council) Under Section 18 of the NCTE Act, 1993 against the said Order.

9. AND WHEREAS the Council concluded that the case may be remanded to the ERC with a direction to send a copy of the appointed staff list submitted through bank for the employees mentioned in the list and take further decision. The Council also observed that ERC need to re-examine the matter concerning the expiry of Lease Deed as mentioned in the complaint dated 14-06-2010.

10. AND WHEREAS as per the direction of the Appeal Committee vide its order F.No.89-137/2012 Appeal/7th Meeting-2012/A56308 dated 17-Aug-2012 the matter of the institution along with original file, was placed in ERC in its 148th meeting held on 3-4 January 2013 and as decided by committee clarification letter was issued to the institution vide No.15911 dated 21st January, 2013.

11. AND WHEREAS the reply of the institution vide letter dated 2-Feb-2013 in response to ERC clarification letter dated 21-Jan-2012 along with other documents and materials submitted by the institution, original file was placed in ERC in its 150th ERC meeting held on 8-9th February 2013 and as decided by the Committee inspection letter was issued vide No.16901 dated 6-3-2013.

12. AND WHEREAS inspection of the institution for shifting of premises was conducted on 30-Mar-2013 and the VTR submitted by the visiting team member along with other documents, original file of the institution was considered in ERC in its 154^{th} ERC meeting held on $22^{\text{nd}} - 23^{\text{rd}}$ April 2013 and decided as follows:

"After considering the records available in the file, and relevant provisions of the NCTE Act 1993, Rules, Regulations and guidelines issued by NCTE Hqrs and VT conducted on new premises for shifting of the building, the Committee discussed the matter in detail and observed as under:

- 1) Recognition be re-stored.
- 2) Permission be granted for shifting of premises.

Accordingly, letters be issued to the institution."

13. NOW, THEREFORE, in pursuance of directions of the Appellate Authority, other related documents submitted by the institution and decision of 154th ERC meeting the Eastern Regional Committee hereby restores the recognition withdrawn vide Order No.ERC/7-130.6(iv).1/2010/11124 dated 14-Apr-2012 on the same terms and conditions as contained in the Recognition Order No.ERC/7-76.6(I)/2007/8175 Dated 04-June-2007 to the institution at new premises viz. Swaraj Nagar Teachers Training College, Po. + Ps. - Khatra Sub Division - Khatra, Dist. - Bankura, West Bengal – 722140.

14. If the institution contravenes any of the above conditions or the provisions of the NCTE Act, Rules, Regulations and Orders made or issued there under, the Regional Committee shall withdraw the recognition as under the provisions of Section 17(1) of the NCTE Act.

15. Further, if the institution is not satisfied with the order, they may prefer an appeal under Section 18 of the NCTE Act in the "Online mode" available on NCTE's website www.ncte-india.org within 60 days of the issue of the order.
