**ORDER**

WHEREAS, Ratulia Secondary Teachers Training Institute, Panskura Vidyasagar Social Welfare Society Building, Vill.- Kanakpur, PO.- Naranda, Dist.- Purba Medinipur, West Bengal - 721139 (APE00573) was granted recognition for B.Ed. course with an intake of 100 from the academic session 2009-2010 vide ERC's Order No.4070 dated 17.05.2010, followed by revised recognition order vide No.32487 dated 30.05.2015 from the academic session 2015-2016 as per NCTE Regulations, 2014 subject to fulfilment of the conditions in respect of enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintain and update website and to comply the same to the ERC.

2. AND WHEREAS, the ERC in its 267<sup>th</sup> Meeting held on 10<sup>th</sup> - 11<sup>th</sup> February, 2019 considered the matter and Show Cause Notice u/s 17(1) was issued on 21.02.2019 to the institution.

3. AND WHEREAS, the institution had failed to submit reply in response to SCN dated 21.02.2019 within stipulated period. The ERC in its 271<sup>st</sup> Meeting held on 24<sup>th</sup> - 25<sup>th</sup> April, 2019 considered the matter and Final Show Cause Notice u/s 17(1) was issued on 18.05.2019 to the institution.

4. AND WHEREAS, the ERC in its 274<sup>th</sup> Meeting held on 15<sup>th</sup> - 16<sup>th</sup> July, 2019 considered the reply dated 16.05.2019 submitted by the institution in response to SCN and accordingly, a letter was issued on 26.08.2019 to the institution on the following ground:-

(i) FDRs in joint mode expired on 25.06.2019 need to be revalidated along with certificate.

5. AND WHEREAS, the ERC in its 278<sup>th</sup> Meeting held on 16<sup>th</sup> - 18<sup>th</sup> January, 2020 considered the original file of the institution along with other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, were carefully considered by ERC and the following observation was made:-

(iii) Non-submission of original FDRs of Rs.5 lakh & Rs.7 lakh as per NCTE Regulation, 2014.

Hence, B.Ed. course is withdrawn under section 17(1) of NCTE Act, 1993 from the next academic session 2020-21.


