WHEREAS, Raiganj B.Ed. College, P.O.- Karnajora, Dist.- Uttar Dinajpur, West Bengal - 733130 (Code No.APE00588) was granted recognition for B.Ed. course with an intake of 100 from the academic session 2012-2013 vide ERC Order No. 8780 dated 14.07.2007, followed by revised order vide No.32162 dated 26.05.2015 from the academic session 2015-2016 as per NCTE Regulations, 2014 subject to fulfilment of the conditions in respect of enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintain and update website and to comply the same to the ERC. A corrigendum was issued to the institution on 09.07.2015 on behalf of the intake reduced from 100 instead of 50.

2. AND WHEREAS, the ERC in its 274th meeting held on 15th - 16th July, 2019, considered the matter and as decided, Show Cause Notice u/s 17(1) was issued on 22.08.2019 to the institution on the following grounds:

- (i) Faculty list comprises 1+12 instead of 1+15 as per NCTE Regulations, 2014.
- (ii) Built up area is not mentioned in building completion certificate.
- (iii) Building plan is not approved by Govt. Engineer.
- (iv) Lecturer in Physical Education and Mathematics are not appointed.

3. AND WHEREAS, the ERC in its 278th Meeting held on 16th - 18th January, 2020 considered the matter along with the reply dated 19.08.2019 submitted by the institution in response to Show Cause Notice and observed as under:

- a) Building Completion Certificate (BCC) is not in the prescribed proforma and not duly signed by the competent authority.
- b) Total land area & built up area is not mentioned in the Building (BP).

In view of the above, the Committee decided as under:

Hence, B.Ed. Course is withdrawn under section 17(1) of NCTE Act, 1993 from the next academic session 2020-2021.


