**ORDER**

WHEREAS, Rabindra Nazrul Smriti B.Ed. Educational Institute, Vill.- Hetampur, P.O.- Hetampur, P.S.- Dubrajpur, Dist.- Birbhum, West Bengal- 731124 (APE00686) was granted recognition for conducting B.Ed. course with an intake of 100 vide ERC order No.9410 dated 11.09.2007, followed by revised order vide dated 26.05.2015 from the academic session 2015-2016 as per NCTE Regulations, 2014 subject to fulfilment of the conditions in respect of enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintain and update website and to comply the same to the ERC.

2. **AND WHEREAS**, the ERC in its 274<sup>th</sup> meeting held on 15<sup>th</sup> – 16<sup>th</sup> July, 2019 considered that 1<sup>st</sup> show cause notice u/s 17(1) issued on 12.03.2019, followed by final show cause notice dated 17.06.2019 on the following grounds:-

- (i) Building completion certificate is not submitted.
- (ii) Photocopy of FDRs are not in joint mode with RD, ERC, NCTE as per Regulations, 2014.
- (iii) Faculties mentioned at sl. No. 1 to 11 of the approved list have been newly appointed after 09.06.2017 who do not possess requisite NET/Ph.D. qualification as per Gazette Notification No. 237 of NCTE published on 09.06.2017.
- (iv) Total built up area mentioned in the building plan as 1463.72 Sq. Mts., which is less than required 2000 Sq. Mts. under NCTE Regulations, 2014 for running 02 units (100 intake) of B.Ed. course.

No reply received and the stipulated time period has already been over.

**In view of the above, the Committee decided as under:**

Recognition granted to B.Ed. course is withdrawn under section 17(1) of NCTE Act, 1993 from the academic session 2020-2021.

3. **NOW THEREFORE**, recognition granted to the institution viz. Rabindra Nazrul Smriti B.Ed. Educational Institute, Vill.- Hetampur, P.O.- Hetampur, P.S.- Dubrajpur, Dist.- Birbhum, West Bengal- 731124 (APE00686) for B.Ed. Course is hereby withdrawn under section 17(1) of NCTE Act, 1993 from the academic session 2020-2021.


