## ORDER

WHEREAS, Uluberia College, P.O.- Uluberia, Dist.- Howrah, West Bengal- 711315 (APE00688) was granted recognition for conducting B.Ed. course with an intake of 100 from the academic session 2008-2009 vide ERC order No.11888 dated 04.08.2008, followed by revised order vide No.32078 dated 25.05.2015 from the academic session 2015-2016 as per NCTE Regulations, 2014 subject to fulfilment of the conditions in respect of enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintain and update website and to comply the same to the ERC.

2. **AND WHEREAS**, the ERC in its 272<sup>nd</sup> meeting held on 30<sup>th</sup> - 31<sup>st</sup> May & 1<sup>st</sup> June, 2019 considered the matter along with reply dated 13.05.2019 (on the basis of proceedings uploaded on ERC website) submitted by the institution in response to Show Cause Notice and observed as under:

(i) Show Cause Notice u/s 17(1) were issued on 21.02.2019 & 21.05.2019.

- (ii) FDRs of Rs.12 lakh (Rs.5 lakh+Rs.7 lakh) towards Endowment and Reserve fund in joint mode with RD, ERC, NCTE along with bank certificate not submitted.
- (iii) Request for exemption of FDRs is not accepted.

In view of the above, the Committee decided as under:

The Committee is of the opinion that recognition granted to B.Ed. course of the application bearing Code No. APE00688 is withdrawn under section 17(1) of NCTE Act, 1993 from the academic session 2020-2021.

3. NOW THEREFORE, recognition granted to the institution viz. Uluberia College, P.O.- Uluberia, Dist.- Howrah, West Bengal- 711315 (APE00688) for B.Ed. Course is hereby withdrawn under section 17(1) of NCTE Act, 1993 with effect from the academic session 2020-2021.
