ORDER

(On Request Reduction of Intake)

WHEREAS, Aurangabad B.Ed. Training College, At.- Aurangabad, P.O.- Aurangabad, Dist.- Murshidabad, West Bengal- 742201 (Code No. APE00712) granted recognition for conducting B.Ed. course with an annual intake of 100 vide ERC's Order number 9409 dated 11.09.2007, followed by revised order vide number 32361 dated 29.05.2015 from the academic session 2015-2016 as per NCTE Regulations, 2014 subject to fulfilment of the conditions in respect of enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintain and update website and to comply the same to the ERC.

2. **AND WHEREAS**, the ERC in its 270th meeting held on 25th – 26th March, 2019 considered the matter along with the reply dated 28.02.2019 submitted by the institution and observed as under:

- (i) As decided by ERC in its 265th meeting, a letter dated 23.01.2019 was issued to the institution to submit copy of resolution of the managing committee with all members duly signed along with Aadhar Card and their address to reduce the intake capacity for B.Ed. course from 100 to 50.
- (ii) The copy of resolution from the Management duly attested by Notary along with Aadhar Card of each members received from the institution.
- (iii) The request of the institution for reducing the intake of B.Ed. course is accepted.

In view of the above, the Committee decided as under:

The intake for B.Ed. course be reduced from 100 to 50 with effect from the academic session 2019-2020 with intimation to the institution and all concerned.


