WHEREAS, Viharilal College of Education, Dept. of Home Science, University of Calcutta, 20 E, Judges Court Road, Alpore, Dist.- Kolkata, West Bengal- 700027 (APE00713) was granted recognition for conducting B.Ed. course with an intake of 100 from the academic session 2009-2010 vide ERC order No.163147 dated 07.05.2009, followed by revised order vide No.32334 dated 28.05.2015 from the academic session 2015-2016 as per NCTE Regulations, 2014 subject to fulfilment of the conditions in respect of enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintain and update website and to comply the same to the ERC.

2. **AND WHEREAS**, the ERC in its 274th meeting held on 15th – 16th July, 2019 considered that 1st show cause notice u/s 17(1) issued on 21.02.2019, followed by final show cause notice dated 20.05.2019 and the institution is still deficient on the following grounds:-

- (i) The institution is unable to submit building completion certificate and building plan vide letter dated 20.05.2019.
- (ii) Request of the institution for extension of time for submission of documents is not accepted.

In view of the above, the Committee decided as under:

Recognition granted to B.Ed. course is withdrawn under section 17(1) of NCTE Act, 1993 from the academic session 2020-2021.

3. NOW THEREFORE, recognition granted to the institution viz. Viharilal College of Education, Dept. of Home Science, University of Calcutta, 20 E, Judges Court Road, Alpore, Dist.- Kolkata, West Bengal- 700027 (APE00713) for B.Ed. Course is hereby withdrawn under section 17(1) of NCTE Act, 1993 from the academic session 2020-2021.
